Welcome to District 02! Our 2014 Spring Conference Committee along with me thanks you for your support in attending this weekend's Area 74 conference. I sincerely hope that you are finding the weekend's activities valuable to your continued recovery and perhaps will recharge your batteries in the areas of Unity, Recovery and Service.

Our district has 6 Sub-districts all with elected Local Committee Members (LCMs) to assist the DCM and alternate-DCM. Currently, the district has 6 standing committees helping carry the message to those in need. All of our LCM positions as well as standing committee chairs are filled. We have one service position open, the liaison to our Fox Valley Central Office. We continue the process of trying to fill that position. Our district has voted to rent a P.O. Box to handle district contributions to the treasurer as well as correspondence to the other standing committees. We will be transferring the use of the Spring Conference P.O. Box to the District following this weekend's activities.

The Archives committee meets every other month. They are currently taking an inventory of what is at hand in the District Archives.

The Corrections committee does a great job of carrying the message into the correctional institutions within our district. Our committee coordinates with the Outagamie and Winnebago County coordinators to carry the message into those facilities. The Corrections literature Moose and Goose fund raiser was held on May 2 in Navarino, WI. Thanks to those who helped with the event as well as those who shared their stories from the inside and experiences doing this type of service work carrying the message to those who are incarcerated.

The Grapevine Committee continues to promote the Grapevine magazine in our District. They continue to give away a yearly subscription to the Grapevine magazine at each intergroup within District 02. Our District newsletter continues to give our members the most up to date information as to what is going on in District 02. Our current circulation is 94 hardcopy and 444 electronic subscriptions. This represents an increase of 4-5% since my last report in March.

The Public Information (PI) committee had been working on updating the District 02 website. They are now working on updating their list of high school counselors within the District.

Our Treatment committee keeps in contact with thirteen treatment facilities within our district. All facilities have meeting lists, literature and BTG forms. They are currently working to assess the continued needs of the treatment facilities. The committee has an active Bridging the Gap member and are actively recruiting speakers for the facilities.

Our Fox Valley Central office has sold out completely the 200 75th Anniversary Big Books that were ordered. They have put in another order to meet demand.

Following this conference, we hope to focus on hosting some workshops within our District. We likely will be reaching out for help from Area Committee chairs where appropriate.

Our District meetings are held on the second Sunday of each month at rotating venues within the district. We continue to average between 20-40 attendees. Our next meeting will be held at the Janssen Center in Appleton on June 8, 2014.

I challenge each of us to focus not on what isn't working; rather what can we do to fill the chairs, our membership has been stagnant for a number of years and that to me, is alarming. We should leave this weekend with a sense of purpose, inspired, charged, and a reminded of why we do this. Find someone who is new in recovery, find someone who is attending their first conference and listen to how their lives are changed. Remember why we do what we do. This service work is a vechicle that allows to do 12<sup>th</sup> step work, and 12the step work is the gift of the program.

We hold district meetings on the first Saturday of every month at 10:00 am, alternating between meeting facilities.

We will continue to attend different meetings in hopes of having discussions regarding the importance of service and the important roles our trusted servants play in carrying the message.
