District 02 Barry B.

District 02 which is the southernmost district in Area 74 extends from Oshkosh in the south to Clintonville and Bonduel in the north. 131 meetings meet within our district weekly. District 02 has six Local Committee Member (L.C.M.) subcommittees who assist the D.C.M. with meeting attendance among other duties. Currently the sub-district positions at the Genesis Club in Appleton and the Northern Winnebago sub-district (Neenah-Menasha area) are vacant. Our alternate D.C.M. and I are continuing to fill in visiting those groups. Our Grapevine committee chair position which was open has been filled. The Fox Valley Central Office liaison position which was filled is again vacant as the individual had to sep down for health reasons. We are considering eliminating the position and just including the steering committee meeting in our monthly newsletter.

The Archives committee meets every other month. They are currently working toward upgrading the District Archives display. They are working to fill the holes in Grapevine issues that they do not possess.

The Corrections committee continues to carry the message into correctional facilities within our district. They are making sure the correct Bridging the Gap form that the inmate completes to begin the BTG process. They are continuing to look for volunteers to go into these correctional facilities. They continue to look for servants to bridge gaps in Oshkosh and Kaukauna. A corrections workshop was held on November 8 at Solutions Recovery Center in Oshkosh.

Our District newsletter continues to give our members the most up to date information as to what is going on in District 02. Our current circulation is 94 hardcopy and 452 electronic subscriptions.

The Public Information (PI) committee continues to work on updating the District 02 website. The District 02 guidelines have been updated and now include the newsletter guidelines and guidelines for including flyers on the website. They are also working on updating the A.A. Hotline Business card for redistribution.

Our Treatment committee keeps in contact with thirteen treatment facilities within our district. All facilities have meeting lists, literature and BTG forms. The Bridging the Gap program continues to pair members with newly discharged individuals from the treatment centers.

The annual District 02 G.S.R. workshop will be held January 17, 2015 from 12:30 to 3:30 PM at Immanuel Lutheran Church in Seymour, WI. Mary Jo R. and Kim R. are our featured speakers. I have brought some flyers for the event.

Our District meetings are held on the second Sunday of each month at rotating venues within the district. We continue to average between 20-40 attendees. Our next meeting will be held December 14, 2014 at First United Methodist Church in Appleton.

District 23 Committee Meetings are held the first Wednesday of each month at Grace Episcopal Church, 218 Humbird St., Rice Lake, WI at 6:30 p.m. All are welcome, at any time – please plan to drop in and join us if you are in the area. An Average of 13 voting members has been present at our district meetings over the last six months.

❖ The District 23 Committee has just finished a plastic laminate Wisconsin road map transposed from the Area 74 Website map, to better understand its own boundaries, and in an effort to help other interested districts better understand theirs. We welcome your review, comments and corrections of any mistakes we might have made.) Please find below what we have determined.

District 23's Geographic/Administrative Boundaries (N, E, S & W):

- 1. The District's northern boundary runs west From Minong, WI into the town of Crazy Corners, WI. (And in doing so, defines District 13's southern boundary.)
- 2. The District's eastern boundary follows State Highway 53 out of Minong, WI in the north and runs into Rice Lake, WI. (And in doing so, defines District 12's eastern boundary.)
- 3. The District is bound on the west by the St. Croix River running roughly from Danbury, WI in the north to Grantsburg in the south; with a 45 degree southeast extension running into Luck, WI. (And in doing so, defines a portion of the northern boundary of District 14.)
- 4. The southern boundary travels east out of Luck, WI, through Cumberland, WI and into Rice Lake, WI. (And in doing so, defines the remaining portion of the northern boundary of District 14 and a small northern portion of District 24's.)
 - (<u>Note</u>: One outcome of this mapping is the recognition that, although not always officially recognized, District 23 administers to and is supported by a significant number of groups strung over a wide area throughout District 24)

Up-dates:

- ❖ The District 23 Committee continues to reorganize and consolidate changes in its operational procedures to better help our groups achieve their collective primary purpose, and to help with the District 23 and its standing committees' continuity and sustainability going into the future.
- Our district continues to implement "Phase I" of our outreach initiative to the groups within our boundaries, the details of which are a matter of record, and are contained in previous reports made to this Area 74 Committee. The main drive has been in visiting our groups in an effort to reconnect, and to reinforce relationships.

-Over -

- "Phase II" of our outreach effort is still in the planning stages, with its main objectives being a plan to offer alternate District Committee Meeting location sites, and creating the opportunity of combined effort workshops with our groups. One such workshop under current consideration is a "Corrections Workshop", which if undertaken, will probably be slated for spring 2015. (Note: There are three County Jails within the area we serve; two of which have ongoing meetings and one that does not.)
- ❖ District 23 has 54 meetings listed currently on the Area 74 website, and is up-dated monthly.
