Report to Area Committee - December 12, 2015

Good morning. I would like to begin by thanking everyone I have had the privilege to serve with over the last 2 years and welcome our new incoming panel 66 servants. I was pleased to hear that we had around 13 people from Area 74 attend the Forum.... and understand that you had fun without me!!! I would like to extend a special thank you to Kim for covering for me while I was recovering from a heart attack I had at the end of September.

At the Fall Conference I passed out some information on submitting suggestions for a theme, presentation and workshop topics for the 2017 General Service Conference. If you have those forms with you I will collect them today and get them emailed to GSO this week.

The Wisconsin Young People in AA will be hosting a conference in Madison on January $8^{th} - 10^{th}$. There are some flyers on the table.

As we near the end of our rotation I would like to remind you to be sure to pass on to the General Service Office the full name, mailing address and daytime phone number and

email address of the incoming committee chairs for your district who will be starting their new terms in January.

I received the General Service Board minutes from their November weekend meeting and would like to highlight some of the items that will be passed on to the 2016 Conference Committees from the corresponding Trustees' Committees.

Trustee's Committee

- The committee discussed a request regarding delegate committee chair voting privileges and a separate request regarding participation by delegate members in the selection of Conference agenda items. These requests will be forwarded to the subcommittee on the Conference Agenda Item Process
- To Policy and Admissions committee the following will be forwarded
 - A request to consider the concept of admitting representatives from the service structure of other 12 Step fellowships to observe the General Service Conference.
 - A requests that all Conference members be sent the same background material, with the exception of digital media and works in progress.
- CPC Committee / Treatment / Special Needs-Accessibilities
 - Will forward the subcommittee recommendation that the pamphlet "Three Talks to the Medical Societies by Bill W." be retired because the pamphlet is too lengthy and dated.
 - will forward the recommendation that "Special Needs" be removed from their committee name and throughout their Composition, Scope and Procedure

Finance and Budgetary Committee

- The Board approved a recommendation to continue the policy of funding the Retiree Medical Benefits plan annually, moving towards 100% within the next 10 years, unless or until other considerations or actions make it unnecessary.
- International Conventions / Regional Forums
 - An approved Board recommendation that Al-Anon be invited to participate in the AA's International Convention in 2020 in Detroit.
- Literature Committee

 To forward to the 2016 Conference Committee on Literature a proposal for the development of a "plain-language" version of *Alcoholics Anonymous*.

Nominating

 the Board approved a recommendation that Josh Eggleston serve as Non-trustee Director on the AA Grapevine Corporate Board following the 2016 General Service Conference

Trustee's Planning and Sharing Session

- Please note: the chairman stated that the trustees are looked upon with respect and admiration by the Fellowship. In light of this he asked the trustees to be mindful of how they present themselves on social media.....I think this is also something worthy of each of us as trusted servants consider and remember.
- The following 3 proposals were discussed and the trustees were in agreement with all and so they will be implemented at the next Sharing and Planning Session during the January Board Weekend.
 - To allow the general manager to attend and participate
 - To allow the executive editor of the Grapevine to attend and participate
 - To allow a staff member of the general manager's choosing to attend and participate
- It was decided that the Workshops during the General Service Conference will be shortened to an hour and a half allowing for additional hour and a half for Conference members to discuss the Feasibility Study. There will also be additional time for presentation and general sharing regarding the Feasibility Study.
- The General Service Board unanimously voted to support database sharing between AAWS and AA Grapevine organizations wherever possible.
- The Ad Hoc Committee on the Bylaws is continuing their work on the Bylaws.
- Under New Business; The Board approved a recommendation to adopt the General Service Board Mission – Vision-Action statement.

- Communicating with and maintaining relationships with General Service structures throughout the world—providing support to help ensure the growth and welfare of the Fellowship worldwide.
- Acting as guardians of A.A.'s Twelve Steps, Twelve Traditions and Twelve Concepts for World Service.

Approved November 2, 2015

AAWS Report

- The new PSA "Doors" continues to perform extremely well. Notably, CNN Airport Network approved the new PSA for its September 2015 rotation. Participating airports include JFK and LaGuardia in New York, Newark Liberty International, Boston Logan International, O'Hara and Midway in Chicago, Miami International, Dulles and Reagan National in Washington, DC.
- Quarterly Web Site report The AAWS Board approved 2 recommendations brought forward by the Technology/Communication/Services Committee.
 - 1. That the following language addressing mobile apps be added to the AAWS Fair Use Policy:
 - a. Can we include brief excerpts from AA material in a mobile app? Permission to reprint AA material must be obtained by contacting the Publishing Department at ippolicy@aa.org. Additionally, AA material

- should represent only a small segment of material in the entire mobile app.
- Can we obtain a license from AA to include an entire publication in a mobile app? No, AAWS does not issue licenses to reproduce its copyrighted material on mobile apps, etc.

Publishing

- AAWS On-line Store: Total web sales for January September 2015 stand at \$5.842.558 which accounts for about 62% of total sales.
- Gross Sales for the first 9 months are about 15% below budget

Financial

 It was noted at the end of the nine month period ending September 30' 2015, revenues were approximately 9.5% less than budgeted and total operating expenses were also under budget. Contributions for the same period are approximately \$97,571 less than budget and were about \$25,000 less than the same period last year.

Personnel

On October 1st we welcomed the new general manager, Greg Tobin. We also welcomed two new staff members: Jeff Wine who has been assigned to the Corrections desk and Sandra Wilson will be on the Literature desk.

AA Grapevine Board Report

- September YTD sales are ahead of projections
- Subscriptions / product sales remain the focus. Organization-wide support is key to addressing the decline in subscriptions. Digital sales cannot grow measurably without wider outreach to non-subscribers. Coordination with local efforts is also important to carrying the message with both Grapevine and LaVina.
- Planning for a mobile friendly version of the Grapevine magazine will continue as the Grapevine Board develops the strategic plan.
- Financially for the 9 months ending September 30th the Grapevine realized a net income of almost \$208,000 instead of the budgeted net loss of \$21,000. Also below budget were Editorial costs, Circulation and Business expenses and General & Administrative expenses. Circulation of the print magazine for the first 9 months averaged 72,495.
- The Grapevine participation in ICYPAA this year included two Record You Story Workshops and two Write Your Story Workshops.
- Language of the Heart is now available in audio book and downloadable files. There were 195 CDs and 64 downloads sold thru September 30th.
- Recent publications include the new Grapevine book "Forming True Partnerships." about relationships in sobriety. It is available in both print and eBook formats.

Lunch vote: 21 yes, 4 no

Fund Chair & Officer Attendance to ECR Conference - Derek T.

Discussion only re: should 1) the Area fund Officers and Committee Chairs to attend the ECR Conference, just as it is funded for the ECR forum? 2) And add a line item to the Budget for it?

Motion would be: That Area 74 fund 10 participants at \$75 each, to include Area Officers, Committee Chairs, and Past Delegates to attend the ECR Conference, and add a line item for it to the budget.

The conference has a service focus that is very useful to Area servants.

The Delegate and Alternate Delegate are already funded to go.

Derek will present as a motion at the next Area Committee Meeting.

AD-Hoc Committee Update- Derek T.

Conducting Area Business (C.A.B.) Ad Hoc Committee of the Area Committee Committee Progress Report, Presented to the Area 74 Area Committee 12/12/15

Committee members: Derek T., Gail Z., Bob M., Sara P., Kim R., Marty L. Pete W. has resigned; the entire committee thanks Pete for his participation and for the excellent minutes he provided as Secretary. All meeting minutes are available in hard copy for review in a 3-ring binder.

Since we last reported to the Area Committee on September 20:

- We have met via conference calls 4 times on September 23, October 7, November 18 and December 2; meeting time totaled ~8 hours as a full committee.
- The committee agreed to create a system so that all of the data could be prioritized efficiently.
- Kim R. agreed to unify all formatting of the data by placing it into XL spreadsheets with additional columns so that each committee could rank every item according to its importance. We used 1, 3 and 5 with 1 being lowest and 5 being highest.
- All committee members performed those tasks; all data has been analyzed and ranked by each committee member.

Our last full discussion centered around whether: 1) the entire data set should be passed on with rankings included or 2) should only the highest ranked items be passed on for review by the Area Committee for distribution to the appropriate committees and officers. We were unable to reach substantial unanimity on this topic.

In summary, the CAB Ad Hoc Committee has reached a point somewhere between the first and second bullet points under Item 3 of our Scope Statement (see below). He committee discussed several options to proceed in light of the fact that we are entering a new rotation in 2016. An ad hoc committee is *formed for a specific task or objective*, and is dissolved after the completion of the task or achievement of the objective. The CAB Ad Hoc Committee has not completed its task but all committee members agree the task could be completed in the near future, therefore:

Motion: The members of the CAB Ad Hoc Committee recommend that the current Ad Hoc Committee be continued to complete its work outlined in the Scope Statement of 03/28/15. Motion passed 25 – 0.

Current carryover balance is \$274.41. At end of December, PO Box fee is \$80 and bulk mail permit is \$220. At beginning of January, \$500 will be needed for printing and mailing of Jan. issue. Bob asked for \$1000 to rollover into the new year. Jay – is Now & Then a committee? Yes.

John O. – do we have a 2016 budget? Yes. Will we have a guarantee this won't happen again? No, this is a recurring issue because Now & Then works differently from the rest of the Committee. Issues need to go out on a monthly basis and expenses can't wait until the next Assembly. People spoke in favor of giving \$1000 to Bob for Now & Then.

The only items that must be in the Now & Then are the Conference Final Report, the Treasurer's report, and Area Conference flyers. Nothing else has to be. Bob & Kathy printed a timetable for what needs to be turned in and when to the Now & Then for printing.

E-newsletter subscription form will give to DCMs to be sent to GSRs to be removed from hard copy, but the form must be filled out completely including group number . E-newsletter will be sent for two years, unless a change is requested sooner. GSRs need to notify the Now & Then of changes.

Greetings from District 16 Area 74,

In looking at the inventory from the "How Are We Doing?" article from the Grapevine July 1952, District 16 is not doing good. It looks at four basic areas in our groups: Growth, Sponsorship, Service Support, and Officers. It would be hard pressed to say that we would get average or passing marks in any category. Our membership is down an estimated 75%, sponsorship is very weak, we have had an attitude of "He knows where we are. If he wants it, he can come and get it." We have relied on treatment centers to supply us with new members, members who have not incurred a debt to A.A. for their sobriety. We have trusted servants but typically they have been the same servants we've had for a long time. We often regard an office as a chore to unload on some unfortunate member. Many of our constituents are senior citizens or disabled and are limited on their ability or capacity to serve.

So where are we now? First we are in trouble, but that's where we as individuals came into A.A. Out of that honesty hopefully we will find the willingness to take a serious, honest inventory and become entirely ready to apply these principles in each group. To quote the article "just as periodic inventory is essential to personal growth, so also is group inventory vital to maximal group success."

Is District 16 in trouble? Yes. Will A.A. collapse in our District? Maybe it will. It says in the article "Groups in different stages of development will, of course, ask different questions. Perhaps in rare instances a group of long standing, like some individuals, may have to start at the beginning. . .with the First Step. . .admit that our group life has become unmanageable. Then what? Naturally, the second Step." We need to get honest, clean house and help others but that is up to each individual and group.
