4) Liability Insurance for Conferences

My name is Barry Brewer, I am an alcoholic and am currently serving as CPC chair for Area 74. When I was a DCM, I had a question from a member that was trying to start a meeting at a facility in District 02. One of the members of the church council requested that a waiver of liability be signed in order to hold meetings at said facility. Apparently it was a directive from the Green Bay diocese. Essentially this would require obtaining a liability insurance policy of some kind.

In the not too distant past, this Area investigated and got some pricing (I believe through the Finance Committee) to have an insurance policy underwritten for Area events. I do not believe this undertaking went past the investigational stage.

In a separate activity, in late 2015, a thread of emails from Area Chairs beginning with Area 15 in South Florida was circulating throughout the country about whether proof of liability insurance was being requested by facilities for Area events (mainly Assemblies and Conferences). I perused through the emails and established the following:

A. No Insurance Required

- Area 74
- Area 51 N. Carolina
- Area 35 N. Minnesota
- Area 33 Michigan No insurance at Area level perhaps a rider to the facilities policy.
- Area 24 Iowa No Area policy If required, purchase a policy for the event.
- Area 34 W. Michigan & E. UP. No insurance required
- Area 86 W. Ontario No insurance at Area level. Occasionally Districts are asked.

B. Insurance Required

- Area 15 South Florida Assemblies at Hotels no cost provided
- Area 1 Alabama & NW FL Not required for Assemblies, required for conferences \$200-300 for \$1M coverage.
- Area 61 Rhode Island Required for annual convention \$290 per year
- Area 23 Southern Indiana requires insurance for Assemblies has Certificate
 of Insurance that they provide to the venue no cost for policy disclosed.
- Area 16 Georgia Has insurance for their Area office have rider for Assemblies
 No cost disclosed.
- Area 28 Maine Has \$1M policy covering their officers for Area events. Also covers their 5 Committee meetings and 2 Assemblies. Cost about \$500 per annum.
- Area 27 Louisiana Insurance to cover Assemblies. Also covers their Archives.
 No cost revealed.
- Area 36 S. Minnesota \$408 per annum. No other information.
- Area 46 New Mexico Insurance to cover Assemblies and state convention No cost disclosed.
- Area 8 San Diego Imperial They apparently have insurance. They check the box yes when asked if requested.
- Area 7 N. California \$1M coverage for 8 ACM, 4 Assemblies & Area Archives -\$1000 annually
- Area 26 Kentucky Most require proof on insurance \$1M per occurrence, \$2M aggregate is \$639 per year
- Area 47 C. New York \$1088 per year (increased from \$640) from Travelers Indemnity Co. thru Charity First NE – 12 events per year - \$1000,000 damage to premises, \$5000 medical expenses, \$1M personal injury, \$2M aggregate
- Area 44 N. New Jersey \$1M coverage ACM, Assemblies sponsored by districts and Area provides the insurance certificate. Annual convention – Convention Committee procures separate policy – No cost provided
- Area 5 S. California Area has insurance policy. Riders are added as needed for additional events. No cost provided.
- Area 29 Maryland Area has a blanket policy & add riders to venues. Also have 2 conventions per year \$500 each for these

My aim today was to restart the dialogue concerning whether the Area should resurrect the task of investigating the need for liability insurance at least for Area events. In out increasingly litigious society, do we become proactive and look into having something underwritten, or wait until a venue requests proof of insurance and we need to scramble to get something in place? In addition, is there someone willing to underwrite a policy that would cover the 600 some meetings in our area that meet in facilities on a weekly basis? As I said, I

just wanted to recommence the exchange of ideas to decide if this is something we need to do. On the other hand, I do not want to spend money unnecessarily. However, as you can see by the examples above, it is likely coming in the future.

When I attended my first District 21meeting three plus years ago there were three of us in the room. Today we have a strong core group of 12 to 14 GSR's, chairpersons and officers, most with multiple responsibilities. Our district meetings now rotate location every three months; and we buy and stock literature in bulk for the convenience and cost savings of all AA's in the district.

A lot of progress has been made, but there is still much work to be done to involve more people in district activities, and to carry the message to those who still suffer.
