## Kim R. Finance Committee Presentation

In the Sept Now \& Then the Finance Committee reported they anticipate needing to access the prudent reserve to meet expenses of the September Assembly. On August 31, 2017 our checking account balance is $\$ 4,331.24$, and it should be noted that I dispersed a check in the amount of $\$ 1,000$ to District 01 on September 2, 2017 for seed money for their Area 74
Conference. That leaves our actual checking account balance \$3,331.24.

That said, the finance committee processes reimbursement requests somewhere between $\$ 3,400$ and $\$ 4,800$ per event. With our checking account balance being $\$ 3,331.24$ we anticipate needing to dip into the prudent reserve and we will remain vigilant in our accounting and reimbursement process. Since this is our elections assembly, we will not have time to discuss this now, but we have asked the Area Chair to leave room on the agenda for conversation in October.

Are there any questions about the Treasurer's report at this time?

The finance committee is distributing the 2018 Proposed Budget, and a booklet of supporting documentation for you to take back to your groups for discussion. Your comments, questions and feedback should be brought back to the October 28 Assembly in Three Lakes.

A couple of noteworthy points as you look at this proposed budget - first, the finance committee unanimously agreed to submit a balanced budget to the Assembly. That will require an increase in $7^{\text {th }}$ tradition participation throughout Area 74 or a decrease in funding requests. Either way it will hopefully increase participation and accountability from our Area Officers and Chairs, as well as AA groups and members within Area 74.

The Finance Committee would also like to make sure committee chairs and officers know they will be invited to answer any Assembly questions relating to their past spending habits which led to their current budget requests.

That brings me to my final point in this budgeting process; Area Chairs and Officers, there are a lot of numbers on this report and we do our best to make sure the numbers are accurate. Please double-check the numbers to make sure your requests are accurate, so I don't repeat the problem I had with the Grapevine numbers, and if you need help with something, please know that we stand ready to serve you.
