to the Area 74 Winter Assembly
04/07/2018**

Hello, my name is Sara Plansky-Pecor and I am an alcoholic. I am currently serving Area 74 as your panel 68 Delegate. I would like to extend a very special welcome to all the new GSR's and DCM's here today. We are so grateful to have you here today to participate in this important event for Area 74. I also want to thank each of you for allowing me this honor and privilege to be able to serve Area 74 in this capacity. Please know that I will do everything I can to be able to best serve Area 74 and our beloved program of Alcoholics Anonymous.

I have been very active in my new service position as Delegate. I am having a hard time believing it is April already. I attended the District 01 AA Intergroup in Green Bay on January 20, 2018. This event had two wonderful speakers who touched my heart as they both were connected to my first sponsor in Alcoholics Anonymous.

On January 27, 2018, I attended the GSR Workshop held in District 02. I will say this Workshop was very well put together and had lots of good information provided.

I had the privilege of attending the 44th Annual East Central Region Conference of Delegates Past and Present during the weekend of February 9 – 11, 2018. This event was held in Indianapolis, Indiana. The purpose of the Conference of Delegates Past and Present is to provide new delegates with a simulated General Service Conference atmosphere and provide a sharing experience relevant to the upcoming General Service Conference. There were eight past and present Area 74 trusted servants in attendance at this event. I learned a lot over this weekend and this experience gave me the opportunity to get acquainted with the other Delegates from our five-state region. I presented my two-minute "Area Highlights" report which I will be presenting at the General Service Conference in April. I could not believe how nervous I was to get up to the podium and present our Area Highlights. It brought me right back here to the first time I stood at this podium two years ago as Area 74 Area Chair. These Area Highlights will be published in the Final Conference Report which will come out later this year.

The background material came out on the Dashboard the same day it was promised which was February 15, 2018. As most of you know this became quite a project for me. I want to apologize for my limitations with using Drop Box for the first time in sending out this background material. I already assured the Area Committee in March that I will not be applying for a job on the Geek Squad at Best Buy any time soon. Thank you for your patience with me concerning this matter. I promise I will do a better job next time in delivering this information to all those involved.

On February 24, 2018, I attended the Pre-Delegate Workshop in District 02. Thank you to all of those who took part in this event as you definitely helped me get started in preparing myself on the General Service Conference Agenda Items. On March 2-4, 2018, I was lucky enough to be able to attend the West Central Region Alcoholics Anonymous Service Conference in West Des Moines, Iowa. This was a wonderful experience that has helped me even more to better

prepare myself for the upcoming General Service Conference. Thank you to Bob M., Past ECR Trustee and Panel 50 Area 74 Delegate, for being willing to bring me along to this event.

On March 10, 2018, I attended the Delegate's Workshop here at the Reiter Center. Thank you to all who participated in this event and helped me to prepare for the upcoming General Service Conference.

I attended the 19th Anniversary of the Came to Believe Group in Wausau, Wisconsin on March 17, 2018. I had the privilege to be able to share for 15 minutes prior to the main speaker about my role as Delegate and what are my duties and responsibilities. We also had some time for questions and answers. I received a very warm welcome and thank Randy O., DCM from District 08 and the Came to Believe Group for this opportunity.

I continue to have almost daily contact either by phone or email with numerous people from Alcoholics Anonymous from Area 74 and elsewhere. I did contact GSO after receiving information from a DCM in our Area that a GSR had to pick up their GSR kit at the post office and pay postage to receive it. I was immediately contacted by the Publishing Operations Manager at GSO and informed that a GSR is not expected to pay postage for the GSR kit. I was told that the post office personnel do occasionally check the package to make sure that it meets all the requirements to be classified as "media mail" and assess additional charges if they deem that it does not. The Publishing Operations Manager thinks that is what happened in this case and asked that I inform her if the group would like to be reimbursed for the additional charge. If anyone else in our Area has experienced this same thing I would ask that you contact me about it.

I have been invited to participate in several upcoming workshops. Please let me know if and when you would like me to come to your District or Workshop to report on the happenings of the General Service Conference or any other topic you desire. I am here to be of service.

I have been invited to participate on a panel at the East Central Regional Conference which will be held on August 24-26, 2018 in Kalamazoo, Michigan. The flyer and registration are out for this upcoming event and they are available at the front table. If you are interested in attending this East Central Regional Conference get in touch with me and if there are enough people wanting to go together, we may be able to rent a van.

I have submitted all of the numerous forms required for my attendance at the General Service Conference April 22-28, 2018. I am very excited to be serving on the Grapevine Committee at the Conference. There is a custom at the General Service Conference that is totally voluntary in which Delegates bring a token from their area to give to the other Delegates as a nice way to get to know one another. I will be bringing along an Area 74 pin as my memento. I ordered extra pins and will have them available for you at the Spring Conference.

I have written monthly articles for the Now & Then. I received two emails in the past week in response to my last Now & Then article. Both emails were from AA members from inactive districts in Area 74. This has given me some ideas on how to reach out to these inactive districts in hopes of getting them active in general service. I have participated in the monthly

Finance teleconference calls. I need to apologize to the assembly body as I did not sit with the Finance Committee during lunch at the Delegate's Workshop on March 10, 2018 when the financial reimbursements were being reviewed. The Finance Chair, Jason L., will be discussing an issue under New Business later today that came up that had I been present I believe may have been avoided. You will see me seated at lunch from here forward during all Area 74 events with the Finance Committee as it is my responsibility to review all financial reimbursements as a member of this committee. I continue to participate in two other weekly conference calls: one that is currently studying AA Comes of Age and the other which studies the Service Manual and other service topics.

On February 20, 2018, I did receive a letter that was sent out from the General Manager, Greg Tobin, from the General Service Office of AA stating that a stipulation was filed with the New York State Supreme Court by AAWS to voluntarily dismiss the case between Alcoholics Anonymous World Services, Inc. and the holder of the 1939 Printer's Copy Manuscript of Alcoholics Anonymous, our Big Book. I did forward this email out to the Area 74 Committee as well as the Past Delegates. If anyone here has not received a copy of this letter and would like me to send it to them, please let me know either today some time or in an email.

There is an opening for an appointed Committee Member for C.P.C. at the General Service Office. The deadline for submitting applications is May 1, 2018. For more information regarding this opening please see Box 459 or see me for details.

I did forward to the Area Committee and Past Delegates the General Service Board unapproved minutes and committee reports from the Board Weekend in January. I have also sent out the AAWS Highlights from both January and March.

On April 5, 2018, I received a Treatment and Accessibilities Activity Update from the Treatment and Accessibilities Coordinator at the General Service Office, Patrick C. There is now a second request for Shared Experience – A.A. in the Military. G.S.O. received quality sharing however, the number of individual responses (18) was lower than hoped. The trustee's asked staff to perform a second round request for shared experience from two different perspectives.

1. How is your committee and/or local members carrying A.A.'s message to alcoholics who are veterans and active duty members of the Armed Services?
2. If you are an A.A. member who is also a veteran or active duty member of the Armed Services, please share how the A.A. message was effectively carried to you. Within the context of military life, what barriers, if any, did you face in receiving the A.A. message? Share any additional information you believe would be helpful.

As Accessibilities Coordinator at G.S.O., Patrick C. provided an update on the project to produce new American Sign Language (ASL) translations of our books *Alcoholics Anonymous* and *Twelve Steps and Twelve Traditions*. The genesis of the project was inspired by sharing the G.S.O. received from local A.A. members who are Deaf, as well as many friends and supporters from the A.A. hearing population. One of the key points shared was a need for the translations to better reflect a currently updated ASL translation. The expressed need for these materials to be updated was heard and the decision was made to include members from the Deaf

community in the project. A G.S.O. committee was formed and agreed to use a local Accessibilities committee, which included Deaf members, to participate in the video reviews and selection of ASL interpreters for the *Big Book* and *Twelve Steps and Twelve Traditions*. The G.S.O. committee was grateful for the local committee's insightful feedback in the selection and review process. A.A.W.S. Publishing assembled a production team that includes a professional ASL consultant with extensive experience in interpreting for the A.A. Fellowship and two professional ASL interpreters. The goal is to develop the best possible ASL translations to help the A.A. members who are Deaf have access to the A.A. message and carry it to the still-suffering alcoholic. The initial filming was completed in January 2018 and the production is currently in the editing phase. Be on the lookout for future communications about the status of this project.

To date, I have used approximately \$550 of my \$2600 annual budget.

Thank you again for the opportunity to serve Area 74 and A.A. as a whole. I would like to thank our Area 74 Registrar, Gerri Ann K. and the Alternate Registrar, Kathy P., for all their hard work in getting the Area Contact Directory as well as our Area 74 AA Groups updated. I would like to thank everyone for participating in today's event and being a direct link in shaping the future of our Fellowship. I appreciate your time and thank you for helping me prepare for the upcoming General Service Conference. If I can be of service, please free to contact me at any time. I ask that you keep me and all trusted servants attending the 68th General Service Conference in your prayers over the next several weeks. I am so excited to move forward with you all on this year's rotation of Panel 68 servants in Area 74 and to follow as our Big Book of Alcoholics Anonymous states on page 77, "Our real purpose is to fit ourselves to be of maximum service to God and the people about us." I am truly humbled for this experience to serve Area 74 and the Fellowship of Alcoholics Anonymous.
