District 10 DCM report, September 16, 2018

District 10 stretches from Mercer, south to Tomahawk, west to Lac du Flambeau and east to Crandon, and includes the cities of Rhinelander, Eagle River, Minocqua, and Antigo. 41 meetings are held weekly throughout our District, for approximately 34 groups.

Our monthly GSR meeting generally meets every second Saturday of the month. Attendance is steady at around 14 people. Most of the attendees are Committee Chairs or Officers. Some Committee Chairs double as GSRs. I counted five GSRs last week, but a couple of people showed up late. All our Committee Chair positions are filled. The most active committees are Corrections and PI/CPC.

We have two new meetings: one is a Big Book Study in Crandon that meets on Thursday nights, at 6:30 pm (I think), the other is an open meeting on Sunday nights at 7 pm in the Mercer Public Library. The Crandon group has applied for a service number with GSO, the Sunday night Mercer meeting is an extension of the Thursday night Mercer group.

We are looking forward to holding a District Inventory on Friday, October 26<sup>th</sup> at the Days Inn in Rhinelander. It starts at 6 pm with pizza and should go until about 9 or 9:30 pm. Because of this we recognize and actively support two allied programs, Al-anon and ACOA. We currently have 25 active AA meetings, as well 6 seasonal meetings running through October 15th. We cooperate with Houghton County's drug court, as

well as local residential treatment facilities and shelters, and although not in our district, continue to support Wednesday night A.A. meetings at Michigan Department of Corrections, Baraga Max.

Our 24-hour A.A. hotline is answered live by Dial Help personnel in Houghton, meetings are listed in our local newspaper, and radio stations are running our PSA's, all at no cost. Our abridged meeting schedule can also be found on the Area 74 website.

Attendance at our District Meetings has been down slightly, but enthusiasm is high. Plans are being made for a November 3rd workshop, as well as our August 2019 Intergroup. We are looking at the third weekend in August, so we do not conflict with this Area Committee Meeting if held. New meeting schedules are at the printer and we are preparing a new 25 second PSA to be aired soon.

We had a rather pleasant surprise at our last district meeting as a representative from a meeting that folded over five years ago turned over their rather substantial treasury to the district.

# Delegate's Report - Sara Plansky-Pecor, 68th Delegate -

Sara asked if her report needed to be heard again. As it was already stated by Sara yesterday at the Assembly. Sara reported that her report is a condensed version of what was said at the 9/15/2018 Assembly and what has transpired since August 11, 2018. You can expect this week, the Anonymity protected digital version of the final report of the 68<sup>th</sup> General Service Conference to area Committee members as well as past delegates and also forward the grid of the proposed conference agenda items.

Also, looking back earlier in the year when the Area Chair did the DCM Committee assignments. After speaking to a couple of DCM's, it seems that it is unclear they understand that they are assigned to a Committee. So if you don't know what committee you're on, please see Sara, Corrections WI has 1, Corrections MI has 1, Archives has no current DCM assigned. The other committees have 2 or 3 DCM'S.

Sara then opened it up for anyone that had questions:

- 1. Randy: DCM 08, Public Service Announcement (PSA) interest, asking how often do you see or hear PSA's in your localities?
- 2. Jeff C: A few PSA's have been heard in Area 75, lower Wisconsin Area. Heard it on three different stations, AM and FM.
- 3. Dean: CPC Chair, 4 years ago they tried to get PSA's on our local radio stations. Back then, it was a very frustrating experience coordinating between GSO and the local radio station. They wouldn't talk to each other, so Dean was middle man. Nothing could be sent to Dean. GSO had to send directly to radio station. But maybe some has changed since and GSO has relaxed some of that.
  - And on a different topic, announced that the CPC Workshop was for professionals and the fellowship that need to interact.
- 4. Jason: Finance Chair, please put on your to do list, there's 2 elections coming up in October, Finance Committee and Structure & Guidelines needs a committee member.
- 5. Barry: Regarding the psa's, The radio stations needed it in a different format than what it came in on the CD from the General Service Office (GSO). The District had to change the format before the station would accept it.
  - Some stations are required to play some PSA's as far as their licensing agreement.

    As far as print for District 04, had internet versions and newspaper print over the holidays, but they do charge.
- 6. Jeff C: Area Committee Meeting addressing our concerns. Having a GSO respond to us in our district, what is the process for that? The process is the Delegate. And another is the Trustee in the region. Because the GSO serves us. We don't serve them. We bring to the Area Committee as a concern and it is a concern because a few Districts have discussed psa's today.
  - The Area Committee addresses the concerns of the Area. They came forward yesterday and addressed their concerns yesterday at the Assembly Sharing Session. It's important that we get our DCM reports, but it's not in our Guidelines. The health of the area and area concerns.
- 7. Derek: Grapevine Chair, if you have a concern, the vehicle to getting that addressed would be under new business. So the concerns that were voiced would be on the Agenda today under new business.

Delegate: What we don't know, we don't know. Looking to clarify, Public Service Announcements (PSA's) was an issue in the past. Based on that, what would be a new agenda item. Derek heard a lot of discussion on the way we do business, the number of service meetings a year, the format. So that could be an agenda item to discuss. So what Derek got was an "area inventory" and remembers the CAB Committee. Maybe it's time for that. Are we discussing things that would help the

Alcoholic the that still suffers? Derek stated that he had several discussions with trusted servants and the CAB committee came up! And brought up the thought of Area Inventory. Maybe it's time. And that would cover a lot of things that have been brought up.

Things brought up today and yesterday, do we add this to our agenda? Area Inventory? And how we're doing business? The PSA's and how they're working in this area?

Derek: We could do this today.

Jeff C: Agenda items for the Area Committee or the Assembly?

Delegate: I don't know. To be honest, I don't know how to do this. I served as Area Chair as well and still unsure, seems like everyone is getting frustrated. Looking for guidance. What do we do?

Derek: Propose for items today. It definitely should be discussed today. Doesn't have to be formal. The time and place to be having those discussion and generating. If motions come out of it, great. At the Area Committee Meeting.

We are looking for guidance on how to and what to add to our meetings. At the Area Committee, discussing those items.

Dean, CPC Chair, was on the PI Committee and remembers discussing that a Conference Motion was made that they were going to change the policy and allow PSA's to be sent directly to members.

Ron: as far as PSA's go, that would be addressed more on district level than on an area level. The FCC requires that it's a public service announcement for free.

Char asked by a show of hands, who is ready for effective change in how we do things in Area 74? Char has a motion ready to go, a few years back there was an Ad Hoc Committee on conducting area business (CAB), they came to a point where they had an immense amount of work of gathering data, and they got hung up on the prioritizing, What do we really need to do and where do we go from here: Take that work and round up a whole new committee, new members and take feed back and incorporate and see what those points are. And we have this other data right available. Start looking at our effectiveness in our Committee structure, how many Assemblies, where do we have redundancies, etc. And agrees that maybe it's time to do the Area Inventory.

Sara agrees. Based on a lot of suggestions from the Assembly yesterday and do we need an Area Committee Meeting or do we just talk in an open thing and air it out?

Mike: Ad Hoc comes up with a solution and they ignore it. So why approach it again? Sara: Because it goes back to the Members, just because the Ad Hoc Committee does the work, Members still have a right to comment. Otherwise we would be a governing body. And that was what was happening in that CAB Committee.

Michelle: So disappointed when the Committee was dissolved. Are we allowed to see what work that Committee had completed?

Dedicate the next Assembly or Committee Meeting where we have a sharing session that we open to everyone in the Area to do some brainstorming and try to go from there as far as changing how we do things here.

Gail: Gail has all the raw data that came out of the CAB Committee, met twice a week, by phone conference, and concluded that they were not as Committee in a position to come up with

recommendations for the body. Tried to rate each recommendation and prioritize it based on that. They looked at it for a year in a half. That information is in archives.

Sara: Hope to keep taking inventory, agrees that the sharing session and todays comments were helpful and will be conductive.

Sara ended with her gratitude and appreciation for all of Area 74 service work.
