From the Area Chair

I hope this finds you all well and sober. A friend of mine tried to relieve some boredom at a function he was at, by reading my last couple of articles for the Now & Then, he found them to be even more boring than whatever he was at. So, if he tries that again at least the first two sentences ought to give him a chuckle, can't vouch for the rest here. Having recently returned from Myrtle Beach visiting my Father, I have done a lot of driving and a lot of thinking. I gave a lot of thought on what It was like and what is like now for me and I found a huge chasm between the two. In my time of sobriety alone there is a big gap between the earliest times of getting sober and today. I came to Alcoholics Anonymous broken and desperate, but with something I had not had in years, a will to live. Prior to coming into Alcoholics Anonymous, I really did not care if I lived or died. I really believe at the end of my drinking God touched me, and I began to fear for my life, and it mattered. Born out of that desperation and fear was a will to do whatever it took to stay sober. The first year of my sobriety was perhaps the most fruitful one. I immersed myself in the three legacies of Alcoholics Anonymous, often doing more than what was expected of me. It was hard work and sometimes tiring, but it was the most fulfilling time of my life. What usually happens for those of us who are fortunate to stick around happened to me also, life got better. I got the better job, got married, got a driver's license, got a car, got possessions, all the things that I lost during my drinking years and more. With these things came more responsibilities and obligations, but also it had purpose and meaning for the first time ever. Things are different today from those early days of sobriety, but one thing has remained immutable, and that is the fact that I need Alcoholics Anonymous just as much today. For me there is no graduation day and I never have God's permission to leave.

When I began looking at my sober life today and comparing to the earlier days, I found some things to be vastly different. For starters, that feeling of desperation and hunger for recovery have abated greatly. I no longer feel a desperation to do more and more in Alcoholics Anonymous, and things that used to inspire me, have become simply things I need to do. I have been taught by mentors in Alcoholics Anonymous to take an unflattering view of myself. The view I have found during all this reflection is that I am no longer inspired or enthused about many aspects in my life. Much of what I do today is about fulfilling obligations and being responsible, not just for Alcoholics Anonymous but for all aspects of life. This no longer has that same sense of awe and inspiration as it did for me in those early years, thankfully it keeps me sober. I think some of this loss is simply a natural occurrence that happens to us all over any considerable period. I tend to feel safe in my sobriety and tend to take it for granted. One thing I have learned over the years, is that nothing stays the same, life is liquid, always moving. Just when I get comfortable and like where things are at, something changes and a whole new adjustment period begins. I don't know for sure if I am at one of those junctions right now, but I do know thanks to Alcoholics Anonymous and God, I will be able to adjust and stay sober. In truth I really don't know where this article is going, I had an initial idea, but it has gone in an entirely different direction. Over the years my life has been just like that, I think it is going in a certain direction and ends up somewhere completely different. I do know that so long as I keep God and Alcoholics Anonymous in my heart and remain willing to do what I can (even kicking and screaming the whole way) that the ride may get bumpy along the way, but it will always be worth it.

NOW & THEN CONVERSION COMMITTEE REPORT

Purpose of Now and Then Conversion Committee

To complete conversion from US Postal Service to primarily digital distribution Assist Co-Editors with creating guidelines for publication in new format Figure out best ways to inform groups/members of new distribution

The committee has met several times and has been working on the following items:

- 1. Price/cost of printing/mail using US Postal Service cost of monthly issue to be \$25 for 12 mos.
- 2. What methods is the N&T going to utilize to 'promote' the changeover -- The committee has proposed sending a letter to all the registered groups without email addresses a group change form with a letter asking them to upgrade their group information by either adding an email address or opting in for receiving a hard copy. Once the one time mailing has gone out, New Group form registrations or change forms will generate an enrollment form if they do not include an email address. The committee hopes to receive assistance from Area Committee members, GSRs, and AA members to make announcements.
- 3. What is the procedure(s) for groups WITH NO MEANS TO RECEIVE N&T BY ELECTRONIC DELIVERY to opt in to receive a hard copy? The committee has determined to send hard copies to those groups that have requested them until the Area74 Assembly approves parameters for how groups can qualify for hard copy mailing. The committee is leaning toward recommending that the the N & T send a hard copy to any registered group that opts-in to receive one. If a group is not registered, the N&T will send a notification letter requesting the group register in order to receive either an email or hard copy. The committee believes this will help get more groups' information up to date and registered. The committee is going to make recommendations but the Assembly will have the final say. So far 10 groups have requested hard copies and 3 individuals have sent the subscription fee to receive a hard copy by USPS.
- 4. **Build the email list** Co-Editors & Area 74 Registrar have been collaborating. List is up to about 775 as of publication of the April 2019 issue. The database has about 300 group emails, N&T has 465 email other than the registered groups' contacts.
- **5.** How can we reach groups in 'dark' districts with no active DCMs? Currently researching which districts are under represented and how we can reach groups in those districts. The Area Chair has been requested by the committee to give his input and help develop communication links with DCMs
- 6. What parameters do we need to establish for materials to include in future issues and what is going to be included in hard copies vs digital versions? The Conversion committee has determined that this is outside the scope of this committee and it is up to the Now & Then editors or the Area Assembly to develop guidelines content

The committee has had 8 members ranging from an AA member familiar with Area 74, Area Committee members (S & G committee member, DCMs, N&T Co-Editor) and a couple other experienced trusted servants who serve other positions besides as AC members. Amber O. has joined the committee and is the pending Co-Editor nominee. It is a good mix and everyone has participated in our weekly calls and taking on tasks to keep moving forward. Explanation of Terms Used on GSC Agenda Items

This is not comprehensive but does attempt to clarify a majority of the most often used terms on the GSC Agenda for trusted servants in Area 74 in attendance at the Delegate's Workshop and Area Assemblies.

Conference Committee - Committee of Delegate's only that meet at the GSC

Trustee's Committee - Committees of The General Service Board that meet throughout the year.

Advisory Action - We call this a Passed Motion in Area 74. Vote at GSC was by Substantial Unanimity.

<u>Additional Consideration</u> - Items discussed, but no action taken or recommendation made, as well as committee recommendations which are not adopted, be included in a separate section in the Conference *Final Report*.

Recommendation - What we call a motion in Area 74. At the GSC, this is open to discussion (or debate if you want to use that term) and will most likely go to a vote for a decision. The only Agenda Items that are open for discussion and vote are recommendations.

- Review Workbooks, Kits etc. Set by Advisory Action of previous GSCs. Workbooks etc. are Service Materials and the contents can be changed from year to year. The purpose is to see that the content in them is what the Fellowship wants in them. It is possible a recommendation could be voted on at the GSC.
- <u>Discuss</u> The corresponding Conference Committee is to have a discussion about the Agenda Item

 There is a good chance there will be a Recommendation or Additional Consideration that comes
 out of the Conference Committee that addresses the Item.
- <u>Consider</u> There is an idea or item that has come to the point that is need of a decision. This will probably come out of a Conference Committee as a Recommendation but may result in an Additional Consideration to the GSC.

Approve - Needs a decision to be made. The action will be taken if approved.

Higher Power?

When I came into AA some years ago in another state, I entered with blinders on. After having spent decades consuming massive amounts of alcohol, as well as having spent my adolescence and young adulthood abusing a vast array of other drugs heavily, I couldn't really see straight walking in the door of AA. Surviving a number of near death experiences, and many ridiculously reckless escapades, I just didn't regard my alcoholic drinking as truly problematic. Yes, I even knew that my drinking practices and their effects on my life were alcoholic in nature, but so what? I'd been drinking this way most of my life, I was quite accustomed to it. Life circumstances had 'conspired' to lead me into AA.

I can still hear the mantras and slogans which were repeated again, and again, and again in the meetings during the early years. "Get out of your own way" "My mind is like a bad neighborhood; you don't want to go in there alone" "Once the cucumber becomes a pickle, you can't go back and be a cucumber again" "Keep coming back; it works if you work it".

Slowly, painstakingly slowly, my immersion in the program of AA continued to penetrate my consciousness. By the time I returned to my home state of WI., I had four solid years under my belt. I had attempted to complete "90 in 90" twice while working full time, but only succeeded in putting in "70 in 70" twice. Afterward, I did average attending 5 meetings per week during those 4 years in another state. I am grateful for those many members who urged us newcomers adamantly to "suit up and show up" to many meetings, to get a home group, read the "Big Book", the "12 & 12", and a host of other conference-approved literature of all sorts. They encouraged us meet their literature "point man", and the Grapevine Rep. Most important, we were encouraged at every meeting to get a sponsor. It took me some months before I followed their advise, and then I met a man I'll never forget no matter how long I live.

AA did and has continually worked for me, as I was extremely fortunate to enter AA in a district which took AA extremely seriously. I am very fortunate to have been spared major struggles with urges to drink. I have, nonetheless, struggled copiously with remaining emotionally sober, and with personality problems, defects of character, shortcomings, a deep inner incongruence and brokenness, and with "practicing these principles in all of [my] affairs".

I remember a crusty old guy who used to slam his fist down on the table at meetings and declare, "AA is all I need, I don't need anything else". I also recall the majority of group members asserting the vital importance of getting a higher power.

In recent years, I've recognized that I've become a crusty old guy with too many lingering wrong-headed ideas about how to live my life. Even though I've returned to "God as 'I' understood Him" from the time of my youth, the same God whom I had forgotten for over 30 years, I have still remained emotionally drunk too much of the time, angry, frustrated, anxious, disconnected, and spent.

I've come to believe that I don't need a higher power. Wait! Don't shoot me yet. What I need to do is decide who or what exactly is my highest power. It seems to me that many higher powers compete for my attention in this life, e.g., federal and state governmental bodies, churches, mosques, synagogues, religious figureheads and other religious entities, sports conglomerates, movie stars, colleges, universities, high powered scientists, that really high paying, high status job, etc. I have to keep it simple. I can't juggle innumerable higher powers and expect to keep everything straight. I have to decide to turn my will and my life over to a power greater than my self, and one who is superior to all of the others. The founders were right. I agree that it isn't easy to do. But I also agree that it is necessary to clear a path on which to walk in recovery, rather than feeling like a pinball too much of the time.

I need AA, because as my sponsor was fond of saying years ago, "It's where I belong". I belong in AA, and it is with other AA members that I belong. The fellowship of AA is just not available to me any where else. But I also need "God as we understood Him". I can't believe that AA World Services repeatedly erred in misprinting this term by italicizing, and underlining it. Bill W., perhaps said it best, "... I am finding that it is much easier to believe that God made man, than that man made God" [As Bill Sees It; # 73].
