From the Area Chair

Greetings Area 74, I hope this finds you all well and sober. This month I would like to write about the current state of this newsletter, how it came about, and the direction it is headed in. As many of you already know a motion to change to a primarily electronic distribution of the Now & Then was passed with substantial unanimity at last October's Assembly in Three Lakes. The idea to go to a primarily electronic distribution has been kicked around in one form or another at Area Assemblies and committee meetings for a few years now. I think that this motion was a good example of how the democratic process of our service structure works. The idea to make this change to our newsletter had been discussed by many for years, and by our Editor during a report at an Assembly in 2017. From that beginning a motion was proposed to go forward with the implementation of this idea at the October assembly in 2017. Much discussion ensued and it was determined that we needed GSR's to go back to their groups for direction on the proposal and the motion was tabled. It continued to be discussed in the following year from Assembly to Assembly and eventually it was voted down due to the language of the motion so a new motion could be drafted to simplify and make clearer the intention of it. A new motion was proposed and seconded and came to the floor at the October 2018 Assembly and was passed with substantial unanimity by the Assembly. As is always our way, the minority opinion (those who voted against the majority) was given the opportunity to speak, and the majority who voted in favor of the motion was asked if they wished to change their vote after hearing the minority opinion (none did). I think as an Area we did what we were supposed to do when any new idea comes forward, we did our due diligence. We went back to our groups for direction, we discussed this thoroughly, we required over 2/3 of those voting to approve to pass this, and we gave those voting against a final say to make sure the majority wasn't missing something. Because we exhausted all avenues and didn't just rush in to make this change should help us all accept the change and move forward (at least that is my hope and understanding).

The implementation of this motion has begun and as is to be expected, has hit a few bumps along the road. First off, not all the groups or individuals have given their email contact to receive the newsletter. I know that there has been a concerted effort to get the word about this, especially by our Editor and Now & Then committee he has been working with. I would like to thank our Editor and the folks who volunteered to help him with this transition, they have all been doing great work and shown awesome dedication. Another thing that may not end up being a big problem but nevertheless needs to be explored, is who can still receive a free hard copy of the newsletter. The motion states that "Groups with no ability to receive an electronic copy may opt in to receive a printed hard copy via the US Postal Service paid for by group contributions received by Area 74." This could leave some grey area as to what constitutes no ability and the committee is working on some ideas to propose at our next Assembly for approval.

Going forward I can already see the benefits of electronic distribution. For one thing it allows someone to get as long winded (like this article is getting IoI) as they wish without having to worry about space. Distributing electronically allows us to print as many pages as we wish without the constraints of feasibility or cost. This opens up a whole plethora of new ideas to come forward, and I for one, hope anyone in Area 74 who wishes to write in for an issue will do so. There is of course the obvious benefit of saving the Area thousands of dollars every year. The money saved could go to countless other worthwhile things.

Like any new thing, growing pains are to be expected. Trial and error will eventually bring the best way to proceed. In time we will either find this idea of electronic distribution to be a great thing with multiple benefits or we may find it isn't the best way. The great thing about our democratic Service Structure is that if we find an idea not working, we can always go back and look at it thoroughly with everyone's voice being heard. This is one of the things I love about Alcoholics Anonymous most, our respect and devotion to the individual while trying to do what is best for the whole.

Purpose of Now and Then Conversion Committee

To complete conversion from US Postal Service to primarily digital distribution Assist Co-Editors with creating guidelines for publication in new format Figure out best ways to inform groups/members of new distribution

The committee has met several times and has been working on the following items:

- 1. Price/cost of printing/mail using US Postal Service cost of monthly issue to be \$25 for 12 mos.
- 2. What methods is the N&T going to utilize to 'promote' the changeover -- we have sent a mailing to registered groups with good mailing addresses and posted an announcement on Area 74 website. Seek assistance from Area Committee members, GSRs, and AA members to make announcements, The committee is still trying to come up with other ideas for 'marketing'
- 3. What is the procedure(s) for groups WITH NO MEANS TO RECEIVE N&T BY

 ELECTRONIC DELIVERY to opt in to receive a hard copy? The committee has determined to send hard copies to those groups that have requested them until the Area74 Assembly approves parameters for how groups can qualify for hard copy mailing. The committee is leaning toward recommending that the the N & T send a hard copy to any registered group that opts-in to receive one. If a group is not registered, the N&T will send a notification letter requesting the group register in order to receive either an email or hard copy. The committee believes this will help get more groups' information up to date and registered.

 The committee is going to make recommendations but the Assembly will have the final say. So far 10 groups have requested hard copies and 3 individuals have sent the subscription fee to receive a hard copy by USPS.
- 4. **Build the email list** Co-Editor & Area 74 Registrar have been collaborating. List is up to about 775 as of publication of the March 2019 issue. The database has about 300 group emails, N&T has 465 email other than the registered groups' contacts.
- **5. Decide on new email server to handle larger mailings** Committee chose Gmail for Business with a cost of \$11 month for up to 2000 emails daily. Still developing the utilization of the service.
- 6. How can we reach groups in 'dark' districts with no active DCMs? Currently researching which districts are under represented and how we can reach groups in those districts. The Area Chair has been requested by the committee to give his input and help develop communication links with DCMs
- 7. What parameters do we need to establish for materials to include in future issues and what is going to be included in hard copies vs digital versions? Discussion starting and we are open to suggestions from the Area 74 membership

The committee now has 8 members ranging from an AA member familiar with Area 74, Area Committee members (S & G committee member, DCMs, N&T Co-Editor) and a couple other experienced trusted servants who serve other positions besides as AC members. Amber O. has joined the committee and is the pending Co-Editor nominee. It is a good mix and everyone is participating in our weekly calls and taking on tasks to keep moving forward. Explanation of Terms Used on GSC Agenda Items

Conference Committee - Committee of Delegate's only that meet at the GSC

Trustee's Committee - Committees of The General Service Board that meet throughout the year.

Advisory Action - We call this a Passed Motion in Area 74. Vote at GSC was by Substantial Unanimity.

<u>Additional Consideration</u> - Items discussed, but no action taken or recommendation made, as well as committee recommendations which are not adopted, be included in a separate section in the Conference *Final Report*.

Recommendation - What we call a motion in Area 74. At the GSC, this is open to discussion (or debate if you want to use that term) and will most likely go to a vote for a decision. The only Agenda Items that are open for discussion and vote are recommendations.

- Review Workbooks, Kits etc. Set by Advisory Action of previous GSCs. Workbooks etc. are Service Materials and the contents can be changed from year to year. The purpose is to see that the content in them is what the Fellowship wants in them. It is possible a recommendation could be voted on at the GSC.
- <u>Discuss</u> The corresponding Conference Committee is to have a discussion about the Agenda Item

 There is a good chance there will be a Recommendation or Additional Consideration that comes
 out of the Conference Committee that addresses the Item.
- <u>Consider</u> There is an idea or item that has come to the point that is need of a decision. This will probably come out of a Conference Committee as a Recommendation but may result in an Additional Consideration to the GSC.

Approve - Needs a decision to be made. The action will be taken if approved.

Ishpeming - Brian M mentioned "There are times that I wonder why I continue to do this. I never see any of the individuals once they are released at any meetings and within a year or less some of them are back." Don then stated "There's a lot of good that does come from us going in and it provides the proper tools that they need when they are released." Don said that he was once one of those individuals and that eventually he was able to get connected after numerous tries.

I am saving the last one to focus on Bill L. who drives on a regular basis to the Baraga Max facility. This has caused a lot of consternation among us because he will drive a good distance, and when he gets there, correctional officers will just say the meeting has been cancelled for no known reason. If you are not familiar with what they say about correctional service and what it takes to become a volunteer, it states that this type of service work is for a special kind of A.A service, and that it is. I have to always remember this when I forget that the only reason I am not doing a life sentence is because I didn't get caught with a lot of what I did.






