The gift of hearing the message, "you don't have to live the way your living if you don't want to anymore." The Area Chairperson will be responsible to organize, conduct, and chair the Area Committee Meetings.

The Alternate Delegate may be asked to act in the stead of the Area Delegate if the Delegate is unavailable. The Alternate Delegate may be asked to perform special duties from time to time at the discretion of the Area, as determined by the voting members of the Area Assemblies.

It is imperative that Area 74 have an Alternate Delegate to assist our seated Delegate. (Past Delegates are ineligible to serve another rotation as delegate.)

For this purpose, we are planning a 2020 International Convention digital site. ## Delegate Report Back 70<sup>th</sup> Virtual General Service Conference 2020: A Clear Vision for You

Excerpt from the opening welcome by Ray M. Saskatchewan, Delegate Chair

Many hours of pre-conference meetings, trainings and pre-rerecord board reports happened prior to the official opening of the 70<sup>th</sup> General Service Conference (GSC) on Saturday May 16, 2020. The opening remarks from Michele Grinberg Chair of the General Service Board directed our thinking in asking "What is best for AA and its Literature in the future?" How to find us in a virtual or real world.? Are societies changing? She reminded of Bill W's words "Vision is, I think, the ability to make good estimates for both the immediate and for the more distant future....Vision is therefore the very essence of prudence". The keynote address was given by Tom A. rotating West Central Regional Trustee. He continued with this year's theme of the conference and talked about how we had four six-hour sessions to take care of AAs essential business...a priceless lesson for AA. We are here to keep the heart of AA beating. We will scrutinize and determine what AA needs, not what we want for AA, yes needs versus wants. He continued to talk about Bill's use of the term flying blind period and so we find ourselves in this period again. Bill clearly states that, "principles are the solution."

In deciding how to put this report together, there were many choices. I put together a power point on the financials and was having so much fun I added the Advisory Actions and a few other items. I wish to start with the 2019 and 2020 financials. I ask that you hold you questions to the end of that portion. After Q&A we will take a short break and then we can start with the Advisory Actions, Floor Motions, And Additional Committee Considerations. I can then answer any questions you may have and talk about the Virtual experience.

The written portion of the report contains the results of the vote. Those Advisory Actions marked with an asterisk I voted in the minority and can provide the reason why. I would like to say a few words about the Additional Committee Considerations with the double asterisk.

- Q. Some members of our group wanted to pass a "virtual" basket to collect Seventh Tradition contributions digitally. How could we do this?
- A. A number of groups have utilized digital payment platforms as an adjunct to passing the basket in the conventional sense in order to provide opportunities for cashless contributions. There are different payment platforms to facilitate this service and it is up to the group to determine which one to use. Some groups have found that a smartphone app-based payment platform is the most efficient, seamless, and minimally disruptive solution for providing a digital contribution. Experience suggests that the treasurer is a likely choice to handle digital contributions, though some groups add more than one trusted servant to share the responsibilities or create a new service position to inform the group about digital payment options and assist other group members who are interested in contributing this way.

# 70TH GENERAL SERVICE CONFERENCE COMMITTEE CONSIDERATIONS

#### **Agenda**

There are no committee considerations from the 2020 Conference Committee on Agenda.

#### **Archives**

• The committee considered requests to develop a book on A.A. history from 1955 through the present and following a lengthy discussion, suggested that the trustees' Archives Committee consider possible themes, content ideas and the time period such a book might cover. The committee requested a report be brought back to the 2021 Conference Committee on Archives.

#### **Cooperation with the Professional Community**

- The committee discussed the request to discontinue the pamphlet "A.A. in Your Community" and took no action. The committee noted that this pamphlet is vital to local C.P.C. committee work to introduce A.A. to professionals and that the title defines A.A. as a community resource. The committee also noted that an update to the language and style is needed.
- The committee requested that the trustees' C.P.C./Treatment and Accessibilities Committee explore ways to update content of the pamphlet "A.A. in Your Community" with a focus on modern professional settings and consider those who consume content in various formats.
  - The committee suggested the following items regarding modern digital resources be considered such as:
    - o The Meeting Guide app o A.A.W.S. and AAGV YouTube channels
    - o A.A.W.S. LinkedIn page o Space to leave local contact information
- The committee requested that a progress report or a draft of "A.A. in Your Community" be brought to the 2021 Conference Committee on Cooperation with the Professional Community.

#### **Corrections** •

- The committee heard a report from the A.A.W.S. publishing director on the efforts to provide digital distribution of A.A. literature into correctional facilities. It was reported that several viable options had been identified to make A.A. literature in digital formats available for alcoholics in correctional settings. The publishing director also provided an update on staple-free pamphlets and reported that the first phase of the plan to publish the most used A.A. pamphlets staple-free is already moving forward.
- The committee reviewed the Corrections Kit and Workbook and provided a list of suggestions. The committee requested that the pamphlet "The 'God' Word" be added to the list of contents for the Kit and suggested several changes in the Workbook to reflect current practices and resources. Finance
- The committee discussed a request to revise the pie chart percentages on page 12 of the pamphlet "Self-Support: Where Money and Spirituality Mix" and the consensus was no changes were needed and took no action as these are suggested percentages.
- The committee reviewed a report from the trustees' Finance Ad Hoc Committee on Google Grants and the Seventh Tradition. The committee strongly suggests forwarding this report to the trustees' Finance and Budgetary Committee and the appropriate 71st General Service Conference committee. (floor action)

#### <u>Grapevine</u>

- The committee considered a request to change the language of the first sentence of the A.A. Preamble as follows: "Alcoholics Anonymous is a fellowship of people who share..." and took no action.
- The committee also discussed making suggested changes to the A.A. Preamble for gender neutral pronouns. The committee requested that the Grapevine Board consider developing examples of generalized language options and that a progress report or draft versions be brought back to the 71st General Service Conference.
- The committee agreed to forward to the AA Grapevine Corporate Board the suggestion that Grapevine produce in the year 2021 or later:

- 1. Step Three Turning It Over (working title) Previously published stories from the pages of Grapevine by A.A. members about their various experiences with Step 3.
- 2. Character Defects Steps 6 & 7 (working title) Previously published stories by A.A. members about their experience with Steps 6 and 7, from the pages of Grapevine.
- The committee agreed to forward to the AA Grapevine Corporate Board the suggestion that Grapevine produce the following La Viña books in the year 2021 or later:
  - 1. AA and Families in Recovery (working title) Spanish-speaking A.A. members share experiences about how drinking affects the whole family and how A.A. helps repair them, from the pages of La Viña.
  - 2. Old-timers Stories (working title) Long-time Spanish-speaking A.A. members share their experience, strength and hope, from the pages of La Viña.
  - 3. Twelve Steps (working title) Spanish-speaking A.A. members share stories of experience with A.A.'s Twelve Steps, from the pages of La Viña.
- The committee discussed a request for AA Grapevine, Inc. to establish an Instagram account in line with the Twelve Traditions and encouraged them to continue with their planning. The committee suggested that the Grapevine Board provide additional information on implementation, anonymity, security, affiliation, outside contributions, privacy, and promotion and bring a progress report back to the 71st GSC.
- The committee discussed ways that AA Grapevine could get feedback on which new book topics to publish. The committee suggested an annual survey in English, Spanish and French be utilized to get input from the Fellowship.

#### **International Conventions/Regional Forums**

- The committee reviewed and accepted a report from the International Convention consultants, Talley Management, outlining the steps taken prior and post cancellation of the 2020 International Convention on March 28, 2020.
- The committee discussed the use of the Lord's Prayer for closing the Big Meetings at the International Convention and had a thoughtful and wide-ranging discussion which included:
  - o The use of the Lord's Prayer in A.A. meetings can create controversy and support the perception of A.A. as a religious organization. 4
  - o Although the prayer is part of the history of A.A. and is widely used and supported in some areas, it could make some members feel excluded.
  - o The benefits of autonomy and keeping the newcomers in mind when selecting how to close A.A. meetings.
  - o The diversity of our Fellowship and the need for everyone to feel included.
  - o Consideration of surveying the Fellowship for a wider sharing regarding use of the Lord's Prayer.
  - o Given the international nature of the International Convention, how the Lord's Prayer is perceived in other countries.
- The committee agreed that further discussion on the use of the Lord's Prayer as a closing at the Big Meetings of the International Convention would be beneficial and suggested that the 2021 Conference Committee on International Conventions/Regional Forums continue discussion at the 71st General Service Conference.
- The committee discussed ways of encouraging interest in Regional and Local Forums and attracting first time attendees and suggested that the General Service Office consider:
  - o Providing options for remote attendance. o Providing digital access to Regional Forum materials and presentations (including use of the Meeting Guide App or mobile app).
  - o Developing service material for host committees providing shared experience on hosting a Regional Forum and stimulating participation.
  - o Developing a "video invitation" from the G.S.B. chair. Suggestions for implementation at the local area included:
  - o Early and consistent communication about Regional Forums, including "What is a Regional Forum; no registration fee; what happens at a forum.
  - o Involve members at all levels of service; do "sponsorship road trips."
  - o Use the Regional Forum video after it is released.

#### <u>Literature</u>

- The committee reviewed the progress report regarding the pamphlet "The Twelve Steps Illustrated" and requested that a progress report or draft pamphlet be brought back to the 2021 Conference Committee on Literature
- The committee reviewed the progress report regarding the pamphlet "The Twelve Concepts Illustrated" and requested that a progress report or draft pamphlet be brought back to the 2021 Conference Literature Committee.

- The committee reviewed the progress report regarding the development of the pamphlet on A.A.'s Three Legacies and requested that a progress report or draft pamphlet be brought back to the 2021 Conference Committee on Literature.
- The committee reviewed a progress report on the revision of the pamphlet "Too Young?" The committee looks forward to reviewing a draft revised pamphlet and/or samples of other potential formats of the pamphlet at the meeting of the 2021 Conference Committee on Literature.
- The committee reviewed a progress report on the revision of the pamphlet "Young People and A.A." The committee looks forward to reviewing a draft revised pamphlet and/or samples of other potential formats of the pamphlet at the meeting of the 2021 Conference Committee on Literature.
- The committee reviewed the progress report regarding the development of the pamphlet for Spanish-speaking women in A.A. and requested that a progress report or draft pamphlet be brought back to the 2021 Conference Committee on Literature.
- The committee considered if proposed agenda items for plain language, simplified language, accessible translations and large print versions of the book Alcoholics Anonymous, as well as workbooks to help study the program of Alcoholics Anonymous, can be addressed with a common solution. The committee requested that the trustees continue to explore this topic. The committee requested that the trustees' make vailable to the Fellowship, as soon as possible, in Spanish, English and French, the presentation "The Big Book: Researching Issues, Possible Tools and Access (70th General Service Conference 2020)" that was presented to the committee during their May 2, 2020 agenda reduction meeting. The committee noted the importance for the Fellowship to be informed about the nature of the accessibility challenges with regard to A.A. literature. The committee requested that a progress report be brought back to the 2021 Conference Committee on Literature. \*\*
- The committee reviewed the progress report regarding safety and A.A. to be included in Living Sober and "Questions and Answers on Sponsorship." The committee requested a review of the draft language be taken with accessibility in mind as it relates to reading level. The committee requested that a progress report or draft pamphlet be brought back to the 2021 Conference Committee on Literature. \*\*
- The committee discussed a draft update of the pamphlet "The Twelve Traditions Illustrated" and noted the accessibility of the language in terms of reading level as well the extent of work done on the current version of the update. \*\* The committee noted that through the process of updating this pamphlet, the final draft update is a distinct item from the original version of "The Twelve Traditions Illustrated," addressing a different audience and serving a different purpose. The committee forwarded to the trustees' Literature Committee suggestions on the draft update which the committee considered a new piece of literature on the Twelve Traditions. The committee requested that a progress report or draft pamphlet be brought back to the 2021 Conference Committee on Literature. \*\*
- The committee discussed not retiring the existing version of the pamphlet "The Twelve Traditions Illustrated" and requested that a written description be provided by the trustees' Literature Committee explaining how an existing version of a literature item might remain in publication after a revised, updated version has been approved, and requested that a report be brought back to the 2021 Conference Committee on Literature. \*\*
- The committee discussed the "A.A.W.S. Policy on Publication of Literature: Updating Pamphlets and Other A.A. Materials," approved by A.A.W.S. in January 2020 and noted that concerns expressed by the 69th General Service Conference were addressed in full by the revised policy.\*\*

#### **Policy/Admissions**

• The committee considered a proposed process for the equitable distribution of Conference committees' workload and noted that the trustees' General Service Conference Committee made significant progress on this complex challenge and further that the proposed process selected by the committee is the appropriate option. The committee agreed that the proposed process would help ensure an equitable distribution of the Conference committees' workload and noted that the Proposed Agenda Item Submission Form would bring much needed structure and clarity to the process. The committee requests that the trustees' General Service Conference Committee clarify the specifics of the proposed plan and bring back a more fully developed process for review by the 2021 General Service Conference.

#### The committee agreed that more specificity is needed on the following:

- o Precisely how this proposed process will impact what will happen regarding agenda items considered at the Fall and Winter trustees' committees' meetings.
- o Clarity on how the proposed process will impact or change the delegate chairs' participation in the Winter Board Weekend and on the Conference Committees' January conference call to obtain feedback on proposed agenda items. The committee noted that significant progress has been made in involving delegates in the agenda item selection process and would not want to take any steps backward.
- o Creating additional primary committees as needed: develop a sample composition, scope and procedures document for an "additional primary committee."

o Provide examples, using sample agenda items, showing how the entire process would work. The committee looks forward to receiving a more detailed plan for this important process for review by the 2021 General Service Conference from the trustees' Committee on the GSC

#### **Public Information**

- The committee reviewed and accepted the 2019 annual report from the trustees' Public Information Committee regarding aa.org and aagrapevine.org.
- The committee reviewed and accepted the G.S.O. Communications' Department report on the A.A.W.S. Meeting Guide App.
- The committee reviewed and accepted the 2019 trustees' Public Information report on the usefulness and effectiveness of the A.A.W.S. YouTube account.
- The committee reviewed and accepted the 2019 trustees' Public Information report on the current status of Google AdWords/Grants and requested that a progress report be brought back to the 2021 Conference Committee on Public Information.
- The committee reviewed and accepted the report of the status of the 2020 Public Information Comprehensive Media Plan. The committee looks forward to reviewing the new architecture being developed and suggested that social media, video/audio content, and accessibility to the A.A. message continue to be a priority in comprehensive media plan discussions.
- The committee reviewed and accepted a draft plan to create video shorts based on A.A. pamphlets. The committee noted the important role of short video content to carry the A.A. message and looks forward to receiving a report at the 2021 meeting of the Conference Committee on Public Information.
- The committee reviewed and accepted the 2019 report on the "Relevance and Usefulness of Video Public Service Announcements." The committee noted the recent efforts by G.S.O. to explore editing a Conference-approved PSA to remain useful for local committees reflecting "social distancing" by A.A. groups and members.
- The committee reviewed and accepted the distribution and tracking information for the video PSA "Changes."

  Note: In keeping with a 2019 Advisory Action this PSA title was updated to "Sobriety in A.A.: We made changes to stop drinking" for search engine optimization (SEO).
- The committee reviewed and accepted a report regarding the new financial reporting system for PSA media valuations.
- The committee reviewed and accepted the report on the development of two PSAs. The committee also expressed that in light of the recent Coronavirus pandemic it would be helpful to include information as to the many formats in which alcoholics find and carry the A.A. message. The committee looks forward to reviewing the two draft PSAs at their 2021 meeting.
- The committee reviewed a request "to create a new form of communication" to address anonymity on social media.

  The committee suggested that the trustees' Public Information Committee continue to discuss this request and that preliminary information be gathered before moving forward. Information to gather:
  - o Shared experience from the Fellowship on how A.A. members adhere to anonymity Traditions on various social media platforms.
  - o Suggested safety and etiquette while using social media.
  - o Anonymity on video meeting platforms. While the committee recognizes that A.A. literature on anonymity is available ("Understanding Anonymity," A.A. Guidelines on Internet, etc.) the committee noted that the content is dated and does not accurately reflect current technology or the Fellowship's experience. Specific, updated material is needed and the consideration that a video service piece to communicate this sharing might be explored. The committee requested that the trustees' Public Information Committee continue these discussions and that a progress report or draft proposal be brought back to the 2021 Conference Committee on Public Information.
- The committee discussed a request to develop a plan to create an A.A. podcast. The committee suggested that G.S.O. explore the development of a draft plan to create a G.S.O. podcast to be brought back to the 2021 Conference Committee on Public Information.
- The committee suggested that information such as function, target audiences, participation, possible episode topics and an implementation plan be included.
- The committee reviewed and accepted the trustees' Public Information Committee report on the A.A. Membership Survey. The committee noted it was encouraged by some of the findings by the survey professional and asked that the trustees' Public Information Committee continue to explore this topic. The committee also suggested the exploration of a possible digital questionnaire feedback form be part of their discussions.
- The committee reviewed the contents of P.I. Kit and Workbook. The committee shared concerns on the relevancy of a print copy workbook and kit for P.I. Committees.
- The committee had the following suggestions:
  - o Explore the development of an A.A. Service Committee app.
  - o Create a new digital PDF version of the Public Information Workbook that can be easily shared, updated by G.S.O. in a timely fashion, and edited locally to better reflect local committee work.

- o Gather broader shared experience from the Fellowship.
- o Include more sharing regarding Accessibilities in P.I. work.
- o Share a more up-to-date reflection of A.A. digital assets and how they can be applied to local P.I. work. (Example: A.A.W.S. YouTube Channel, Meeting Guide app, online video/e-radio PSA placement, QR Codes, virtual A.A. meetings/events/presentations etc.)
- o Include more short content communication templates to carry the A.A. message to the public. The committee suggested that the trustees' Public Information Committee discuss this request and that a report be brought back to the 2021 Conference Committee on Public Information on these efforts.

#### **Report and Charter**

The committee accepted a report from the Publishing department outlining the General Service Office process for timely and accurate preparation and publication of the 2020 General Service Conference Final Report.

- The committee discussed restoring the two paragraphs with the accompanying footnote in the Concept Eleven essay of The Twelve Concepts for World Service that were removed by an Advisory Action of the 66th General Service Conference and took no action. The committee agreed that the footnote noting that the two paragraphs are available upon request from the G.S.O. Archives department is adequate.
- The committee reviewed the draft of The A.A. Service Manual, 2020-2022 Edition and noted the significant progress made toward the goals agreed upon by the 2019 Conference Committee on Report and Charter. The committee requested that an updated draft be brought back to the 2021 Conference Committee on Report and Charter. The committee will forward suggestions for the next draft to the Publishing department.

#### **Treatment & Accessibilities**

- The committee suggested that the trustees' C.P.C./T.A. committee develop a Bridging the Gap Committee Workbook and provide a progress report to the 2021 General Service Conference. The committee suggested that the shared experience included in the workbook include a list of BTG temporary contacts available from G.S.O.
- The committee reviewed the progress report, "Review of Bridging the Gap Materials," and felt it met the goal of the 2019 committee consideration. The committee suggested that rather than combine Bridging the Gap related service materials, the trustees' C.P.C./T.A. committee consider updating existing service materials to reflect the suggested language updates for currency and inclusion. The committee expressed support for use of a "Question and Answer" style in the content across the range of Bridging the Gap related items. The committee also expressed support for the sample version of "A.A. Guidelines: Bridging the Gap/Temporary Contact Committees" included in the report.
- The committee reviewed the progress report on updating the pamphlet "A.A. for the Older Alcoholic." The committee noted that the submitted stories did not indicate a broad and diverse representation of A.A. experience and suggested a reopened call for stories based on the following experiences provided by trustees' C.P.C./Treatment and Accessibilities Committees:
  - o Ethnic, cultural and LGBTQ communities o Lifestyle diversity o Got sober later in life
  - o Veterans from the Vietnam War or later o Hearing loss or mobility issues
  - o Online or telephone A.A. meetings
  - o Dementia or Alzheimer mental health issues o Spiritual pathways The committee looks forward to a progress report or draft pamphlet to be brought to the 2021 Conference Committee on Treatment and Accessibilities.
- The committee reviewed the Treatment Committee Kit and Workbook and forwarded a list of suggestions to the trustees' C.P.C./Treatment and Accessibilities Committee.
- The committee reviewed the Accessibilities Kit and Workbook and forwarded a list of suggestions to the trustees' C.P.C./Treatment and Accessibilities Committee.

#### **Trustees**

- The committee reviewed the resumes and approved as eligible for election all Class B trustee candidates for West Central and Western Canada Regional trustee.
- The 2020 Conference Committee on Trustees reviewed the slate of directors of A.A. World Services, Inc. and A.A.

Question was asked about in agreement on the understanding of what the vote is today, the vote was 40 YES -7 No, in response to the question: "Does everyone agree with this voice for voting

Clarification on what the vote was for and that people who didn't understand what the vote was for should ask for clarification. No hands raised.

Question asked if there were to be discussion and if there is a no vote would the committee have full decision making on the conference.

Area Chair stated that it is up to the committee to move forward. Chair clarified that the committee can put forward what they want to do with the bid.

#### Poll was issued:

- YES = Hold a Fall Conference face-to-face as planned in Eau Claire
- NO = Do not have a face-to-face conference in Eau Claire

Poll results: 80.76% No(42) 19.34% Yes(10) – substantial unanimity

#### Minority Opinion:

The longer we stay away the easier it is to stay away and not sure the founders would want that. I also voted yes that the host district that they serve at the pleasure of the Area and although we have vague guidelines that we follow it is Area 74 as a whole that puts on the conference and that the options that were put forward didn't capture all options of having a limited conference was not an option. This is an Area 74 Conference and we should have some say in how it goes forward. We have options and we could look at many options and we should gather in person.

Another person commented that we have options to consider to meet in person. We could find larger spaces, pre-packaged food and should have fun this fall.

Another person commented that they voted yes because the way the motion was crafted was that it throws it back to the committee and that the Area guidelines have a loose committee and that the Area should work with the District's conference planning committee and that this vote gives no direction on what to do from here. Opening and Welcome Remarks: Meeting called to order at 7:03am, serenity prayer. Past delegate Marty L chaired the meeting at the request of the current delegate.

Roll CallDelegate, Secretary, Treasurer, Registar, Corrections – MI, Treatment, CPC, N & T, Grapevine, Literature – x DCM: 2 3 4 5 6 7 10 12 13 20 21

Motion made to table minutes, 2nded. No discussion. Approved unanimously by audio vote.

The first discussion- to include that these items to be voted on just mean a special Assembly needs to take place to act on the recommendations this Area Committee makes.

**Review:** A formal Assembly vote was not taken on whether we wished to hold the August 1, 2020 Inventory and proposed ACM in person at Three Lakes Wisconsin with Zoom technology for those with medical exemptions or a completely virtual meeting.

**Question:** Do we need to hold a formal Assembly Vote on whether we wished to hold the August 1, 2020 Inventory and proposed ACM in person at Three Lakes Wisconsin with Zoom technology for those with medical exemptions or a completely virtual meeting.

Open for Discussion, Debate and possible vote

Question about who is able to attend and participate and if there are any questions on the agenda prior to beginning. Marty stated that only members of the ACM are able to participate. Question regarding why we don't have on the agenda any discussion of the vacant chair / alternate delegate position. Discussion item on the vacant chair / alternate delegate will be added to the discussion after the scheduled items. Comment made that an open position can be voted on at any Area business meeting. Marty stated that traditionally it was done at assemblies.

Comment: Seeking clarification on what the question is. Delegate clarified a vote was never taken on the matter and this question and do we need to actually take a vote on the matter so that every voice is heard.

Comment: I do feel that the Assembly gets to vote on this.

Comment: Another comment agreed.

Comment: Clarification that Geri was working on this and asking what her input is on that. Delegate stated that she spoke with Geri Ann and has no direction from the committee.

Comment: Statement that her understanding was that the inventory was being held and that it might be in person and virtual.

Comment: Nicholas's comment

Comment: Comment that another person from the committee is present and they could shed some light.

Comment: Question that this is being driven by the state and that the decision was already informed that we are going to do

Comment: Member of the Area inventory committee spoke that they have not met. Believed that the chairperson had stated in past conversations that the committee is comfortable holding in completely in person.

Comment: Char stated that she spoke with Reiter center and that they have not been able to make any decisions because every group has cancelled. Char stated that Reiter center would not enforce local rules, that it would be safe and it would work.

Comment: Can there be a hybrid?

Comment: Clarification is whether we need to vote or not, not what our options are. Medical exemptions are simply those that don't want to attend.

Comment: Clarification on that the vote would need to be taken before the inventory occurs.

Comment: DCM shared a letter written by his GSR's. Statement from DCM stating that he agreed with letter and that was frustrated with the short notice of the ACM. (Attachment 1)

Comment: Was a question was any DCM's able to speak to their GSRs.

Comment: DCM completely concurred with the letter previously read. Believes calling the meeting negates the GSR's – their voice and vote. Also does not agree with the letter written in the Now & Then and is completely inappropriate.

Comment: DCM did not share with his GSRs that his meeting emergency meeting was happening and he did have an email from a GSR that paraphrased "that after Sunday's affair he was disgusted by political affair and it lasted to long and had to leave after 4.5 hours to escape to a more serene place."

Comment: Goal today to establish a well-informed group conscious and that isn't possible without GSRs. District 05 is not in accordance with holding another assembly.

Comment: District 6 is trying to get started again and one of the road blocks is getting people involved. They question about why are we (GSRs) going to get involved and if the business is going to be done without their input.

Comment: DCM stated we are having an assembly to include the GSRs. A vote should have been taken and that the last assembly was ridiculous. A lot of GSR's didn't take a vote and that this an unprecedented time. Voices have been heard and it was pretty much substantial unanimity and that she understands the wording of medical exemption could be offensive. Right of decision is

a great concept that is why we should have an inventory and we can talk about the inventory. Encouraged DCMs to hold a special meeting.

Comment: Char stated that the inventory will occur on August 1st.

Comment: Can we call to question? – Call to question.

Comment: This isn't a formal motion. Marty sought clarification.

Comment: Motion made, "To not hold a special assembly vote on the inventory prior to the August 1st, 2020 Inventory meeting."

Comment: Char asked we want to amend the motion to state that is should be virtual vs in-person. Char then asked if we needed to make a friendly motion that vote is not taken.

Comment: We need to clarify what the special assembly is for.

Comment: It states that the motion does not specifically address the concerns.

Comment: This is getting complicated. Do we need to hold a formal assembly vote prior to August 1<sup>st</sup> so the motion as amended sounds ok. Aren't we talking about a formal assembly vote? Isn't that what we are talking about.

Comment: Can one of our hosts put this in the document and share it with the voting body.

Comment: Call to question, 2<sup>nd</sup>.

#### Vote: Yes - 79% (15) No - 21% (4),

Comment: Clarification on voting body, 21 eligible voting members.

Comment: Invitation for minority to speak.

Comment: Minority opinion, I don't want to vote in favor of not allowing the assembly to have a voice and vote in the matter and am more than willing to go along with the majority.

Comment: No one from majority wishes to change their vote.

#### Motion passed to not hold special assembly vote regarding inventory.

Comment: Asking the body if in approval of not following the agenda to move to last question on agenda on regarding a formal vote in person – being that the items are so similar.

Comment: Question was when we took the vote was not the assembly included.

Comment: Char stated that she wants to hold a conversation on Delegated Authority Concept X and the Area 74 Guidelines.

Comment: GSRs were asked to get back to their groups and the assembly meeting was regarding the conference and that her recollection was that it was not discussed regarding the assembly.

Comment: No discussion on if there was a discussion on votes specifically for an assembly. An assembly needs to occur to sort out.

#### **Review:** Delegated Authority Concept X and the Area 74 Guidelines

**Question:** Does a conference planning committee have the authority to state what happens with the Assembly? Open for Discussion, Debate and possible vote.

Comment: I think what I'm hearing is that does the planning committee have authority to impact or dictate the assembly. Often it is based on the facility. To rectify that you need to have that cleared ahead of time and have logistics sorted out. There needs to be some delegated authority to the conference planning committee.

Comment: Point out that Article 4 that the fall assembly is held with the conference. This committee moved forward that the Area Assembly would be moving forward on September 12 (stated by chair). The conference committee met and moved speakers around to allow that the assembly will be held on Saturday and did not want people on Zoom for 8 hours. The conference wanted to be mindful for the assembly. Also stated that because that the guidelines say that they are held in conjunction with the conference that the vote was the also the assembly would be held virtual as well.

Comment: Nicholas's comment. Delegated authority -full body "letter kills – spirit gives life"

Comment: History of who hosts conferences and what has historically been done. Discussion with our inventory and CAB reloaded will help determine what things will look like going forward. Many other areas have area committee members sit on conference planning committee to help ensure that the Area's business can be done.

Comment: GSR's got feedback and the discussion was specifically on the conference and not assembly and maybe confusion as to what the vote was on, conference vs. assembly.

Comment: Char stated that discussion was not allowed and new information could have been brought forward and that was not allowed. I stand behind that the conference is virtual. I question the guidelines about the assembly being held in conjunction with the conference. Other options were not discussed or brought forward. In conversations with the Reiter center that we can meet in person with Zoom technology but on a different weekend. I am personally uncomfortable with what has been decided. The motions go out and are vague and confusing.

Comment: I wanted to clarify that the Delegates Report back was given at the Spring Assembly in Green Bay on 2018.

Comment: Happy Birthday Sara! ©

Comment: Clarification on what the conference would be.

Comment: Speakers will occur on Friday night and Sunday morning – Saturday is left open the Area to hold an assembly.

Comment: Nicholas's comment on spirit and letter

Comment: 2<sup>nd</sup> to previous comment. Objections could have been raised and were not.

Comment: Considering current social circumstances that we are establishing a new norm and we need to move forward and learn from our mistakes.

Comment: Marty stated what he is hearing is that the conference planning committee has left the day (Saturday) open for the assembly and perhaps the idea of delegated authority and could be left for a sharing session at an assembly.

**Question:** Do we need to take a formal vote on holding the Assembly in person at Three Lakes Wisconsin Saturday September 26, 2020 with Zoom technology for those with medical exemptions or a completely virtual meeting.

Open for Discussion, Debate and possible vote

Comment: Marty stated that clarification; the conference has left Saturday open for the assembly and that the Reiter center is not, so it would need to be on the 26<sup>th</sup>.

Comment: Clarification that the conference has left the day open with on programming scheduled for the day. An ASL interpreter has been arranged for the  $12^{th}$  for the assembly as that was what the treatment committee believed.

Comment: I am completed against changing the date to the 26<sup>th</sup>. I am not sure where that would have come from. The substantial unanimity has been to be meeting virtual. It was stated that our assembly would be happening that day and the ACM would be on the following on Sunday. We still have question regarding delegate feedback.

Comment: Motion: "Move that the assembly be held virtually in conjunction with the conference on September 12<sup>th</sup> and the ACM on the 13<sup>th</sup>."

Comment: Clarification on would this address the question?

Comment: Char asked if the current motion could be amended to state that based on previous discussion and feedback.

#### Motion: "The fall assembly will be held on Saturday, September 12, 2020

Comment: It should be noted that vote is not needed because it has already been heard and not that it isn't important.

Comment: I understand where the motion is coming from and that can we say that a vote is not needed. Are we setting a bad precedent?

Comment: I would be opposed to those motion because I fully understood that we discussed having the assembly on the 12<sup>th</sup> and the ACM on the 13<sup>th</sup>. I disagree with the question being posed to us. The dates were set and we should not tell the assembly.

Comment: The dates were already set and we should just move forward with the dates that are set and we don't need this motion.

Comment: My intent with the motion was that the voice was not needed by the assembly.

Comment: I believe the assembly was involved because we held a special emergency assembly and their voice was heard.

Comment: Didn't hear an acceptance of the friendly amendment. I have not heard of the 9/26/20 date until this agenda. My take away was the assembly and ACM would be occurring virtually and although we did not take a vote that the assembly was on consensus. The motion could be withdrawn.

Comment: The 26<sup>th</sup> date was never mentioned because a hybrid meeting was not discussed and this is the date the Reiter center is available. Can a friendly amendment be offered that verbiage is added that no special assembly is needed?

#### Motion withdrawn

Comment: Vote: Do we need to take a formal vote on holding the Assembly in person at Three Lakes Wisconsin Saturday September 26, 2020 with Zoom technology for those with medical exemptions or a completely virtual meeting.

Vote: Yes - 19% (3) No -81%(13),

Comment: I voted yes because of the way it is written. I was concerned that the if I voted no that we could just move forward with an assembly on the  $26^{th}$  and I don't want that.

Comment: Every year we vote on a calendar and now we are adding to the calendar that we are not voting on it.

Comment: A move to reconsider and open discussion, seconded.

Vote: Yes -24 % (4) No - 76% (13), Vote is final

Discussion on vacancy of Area Chair – Alternate- Delegate.

Comment: Marty brought up service guidelines which stated how to interpret them.

Comment: Brought this up that the Service Manual states the Delegate can appoint a chair and if a past delegate is appointed, they cannot serve as delegate.

Comment: In reading section 6 that the Area can describe at its discretion, please describe "area". We need to discuss this and keep that in mind.

Comment: Char stated the in speaking with people that direction was given was to hold an election at the next full assembly and is it time to look at splitting the role of Area Chair and Alternate Delegate. She has agreed to chair in September and does not wish to do so after.

Comment: If you can't find someone to step up and can we look at who was standing.

Comment: Char stated no one else stood for Delegate and Dawn stood for chair.

Comment: This is the situation our Area has created and we need to address it in September.

Comment: Trust the process. Reach out to our Area and bring nominations at our assembly in September.

Comment: Agreed that we vote in September.

Comment: Making sure we are all aware that the consequences of the decision that we could be w/o a delegate.

Comment: DCM's need to go back to their districts and gsrs to bring forward nominations.

Comment: Could we review the requirements for the position?

Comment: Section 5.00 The Alternate Area Delegate shall serve as the Area Chairperson, and as such has the responsibility for chairing Area Service Meetings at conferences and at Assemblies. In Area 74 the Alternate Delegate shall have previously served as a DCM. The Alternate Delegate is responsible for the agenda of Service Meetings, seeing to it that requests by members of Area 74 are addressed in an organized and timely fashion. Agendas should be published in the Area newsletter prior to Service Meetings, and

copies should be available the day of the meeting. The Area Chairperson will be responsible to organize, conduct, and chair the Area Committee Meetings. The Alternate Delegate may be asked to act in the stead of the Area Delegate if the Delegate is unavailable. The Alternate Delegate may be asked to perform special duties from time to time at the discretion of the Area, as determined by the voting members of the Area Assemblies.

Comment: This body (ACM) will move forward without and Area Chair / Alternate delegate until the September Assembly.

Comment: A current serving DCM precedent has been done and that they need to resign their position first.

Comment: Char wanted to ask about October assembly. Char is hearing a lot of people want to want to get back together in person and that we need to figure out what to do. We also need to make another ACM in December. Char cautions that Zoom is convenient. Is that what service is all about?

Comment: What are the dates for October assembly?

Comment: October assembly is 10/24/20 at 3 Lakes for the Reiter Center.

Comment: That the Delegate continues to share personal opinion and is influencing the body.

Comment: Echo comments regarding delegate.

Comment: Unless we need to make a decision sooner, we can make those decision on 9/12/2020.

Comment: Echo previous comments regarding delegate.

Comment: Echo previous comments regarding delegate. Can we stop worrying the October assembly can we talk about Delegates Report back.

Comment: Perfect example of the ACM should work. DCM's go back to their districts and get feedback.

Comment: Precedent was set that the Area Chair expressed their views and that was accepted and she should be able to share as well. In regards to the Delegate's report back. The Area chair was to set that up and sense she has stepped down that she will set that up. Waiting for more information from GSO to finalized items. The arguments about making more dates is what happens when we have a pandemic.

Comment: Appreciate patience and acknowledging the challenging times of what we are doing.
