When anyone, anywhere, reaches out for help, I want the hand of A.A. always to be there. And for that: I am responsible.

### AREA 74 COOPERATION WITH PROFESSIONALS COMMITTEE MOTION & BACKGROUND

Area 74 CPC Committee **recommends** with unanimity to the Area 74 Assembly that:

"The LinkedIn page of Alcoholics Anonymous be discontinued. In addition, we recommend that the Area Delegate carries this Area Conscience to the 70th General Service Conference."

We recommend the following actions to carry out this recommendation:

- If a recommendation similar to this comes to the floor of the 70<sup>th</sup> GSC then our Delegate votes yes to discontinue LindkedIn or;
- If no agenda item to discontinue LindkedIn is brought to the floor, then we request our Delegate to present this as a floor action or;
- If our Delegate is unable to introduce this agenda item, then we would ask that it be sent to the GSC Coordinator as an agenda item, along with our background for the 71<sup>st</sup> General Service Conference.
- LinkedIn is not effective.
  - The total number of LinkedIn users is 476 million. There were Total page visits in November 2019 of 692 with ONLY 80 clicks to visit aa.org.
    - Would a professional go to LinkedIn when they may go directly to aa.org or A.A.W.S.?
- Advertising on LinkedIn

- o LinkedIn cannot prevent Ads from appearing on a Company Page. Web ads (called "promoted content" by LinkedIn) appear on the far-right column of LinkedIn pages.
  - This could lead to an appearance of Affiliation or Endorsement, Actual or Implied, and promotion.
  - Tradition Six "While an A.A. group may cooperate with anyone, such cooperation ought never to go so far as affiliation or endorsement, actual or implied."
  - Tradition Eleven "Our public relations policy is based on attraction rather than promotion; we need always maintain personal anonymity at the level of press, radio, and films."
- Keeping in mind the responsibilities as outlined in the AA Service Manual our committee believes a CPC presence on LinkedIn usurps responsibility from local C.P.C. committees or discouraging face-to-face interactions with professionals.
  - GSO presence on LinkedIn discourages face to face interaction between an AA Member and the Professional
- Use LinkedIn to broaden the reach of our "About A.A." newsletter. "Request that the professionals who are quoted or profiled in the issues post about the newsletter to reach their LinkedIn connections"
  - O How is quoting professionals providing the message of AA? Or are we promoting professionals and their views?
    - This could appear as Seeking Prestige
    - Tradition Six: "An A.A. group ought never endorse, finance, or lend the A.A. name to any related facility or outside enterprise, lest problems of money, property, and prestige divert us from our primary purpose." This Tradition reminds us never to give the impression that A.A. itself, or any A.A. group, endorses (or opposes) or finances any other enterprise, no matter what our individual opinions may be. It also points out that seeking prestige always creates problems for us.
- Broaden the search for Class A Trustees
  - Feature openings for Class A Trustees on our Company Page, "push the information out by posting the opening to all our followers", "we could push the information out by posting the opening to LinkedIn Groups" and "target certain professions"
    - Pg. S68 The AA Service Manual "The General Service Board nominates Class A trustees after an extensive search and interview process that begins by asking current and past members of the board, directors, delegates, and G.S.O. and Grapevine staff to submit names and background information for "friends of A.A." to fill a vacancy."
    - Are we changing the process for finding Class A Trustees?
    - Our committee does not see a need to "broaden" the search for Class A Trustees.
    - We believe that "targeting" audiences do not follow AA Principles.
    - We believe that "pushing" for candidates from a "Company Page" sends a conflicting AA message of what AA is about.
    - This type of searching might encourage "Professionals" to apply that have no interest in the AA Fellowship, understanding of AA Principles and are only applying to embellish their resumes.
- "post pieces from current and past Class A Trustees and other professionals who are friends of A.A."
  - We believe that publishing Class A Trustee sharing on a public media platform does not follow our AA Principles or past traditions.
  - Looking at our AA history sharing by Class ATrustee's was normally accomplished through professional journals and talks at professional conventions and the like.
  - Tradition 11 (long form) says, in part, "Our public relations should be guided by the principle of attraction rather than promotion. There is never need to praise ourselves.
  - This might become an expectation for future Class A Trustee's that part of their responsibilities will be as recruiters.
- LinkedIn to announce national, state, and local conferences where A.A. will be exhibiting.
  - o By posting that we will be exhibiting at a professional conference are we promoting that conference?
    - Is this Affiliation or Endorsement, Actual or Implied, or promotion?
       Tradition Six "cooperation ought never to go so far as affiliation or endorsement, actual or implied."

- Tradition Eleven "Our public relations policy is based on attraction rather than promotion"
- "post studies, new findings, and new resources that might become available from reputable sources
  - o "Feature links to studies and articles related to alcoholism from reputable sources", "post these studies and articles to our followers" and "post these studies to the appropriate LinkedIn Groups"
    - Alcoholics Anonymous does not decide who or what is a reputable source.
    - Posting "studies, findings, new resources" could imply affiliation or endorsements and both are violations of our AA Traditions
  - o "with appropriate disclaimers similar to what Grapevine uses"
    - The disclaimer may remove actual endorsement or affiliation, but-does leave implications.
  - "Posting material by reputable sources shows professionals that Alcoholics Anonymous is a subject matter expert on alcoholism."
    - There is no mention in the Alcoholics Anonymous book that we are "Experts" To imply that we are experts is not in line with our spiritual principles.
    - Posting studies or articles implies that we agree with or endorse the content –we do not post
      articles or studies we do not agree with. Or for that matter any other recovery material but
      conference approved.
    - Tradition Six "cooperation ought never to go so far as affiliation or endorsement, actual or implied."
    - Tradition Eleven "Our public relations policy is based on attraction rather than promotion"
    - This type of prestige will divert-us from our primary purpose.
  - o "authors of the articles or studies might be more inclined to become Class A Trustees because of our support of their work"
    - We cooperate with others we do not endorse them. Or their work
- IMPLEMENTATION: "C.P.C. coordinator and the C.P.C. assistant be the page administrators". "The Company page administrators need to be LinkedIn members and use their real first and last names, but profile photos are not required. The current C.P.C. assistant is a nonalcoholic so there are no anonymity issues there."
  - O What about the anonymity of the nonalcoholic CPC Assistant?
    - "Our public relations policy is based on attraction rather than promotion; we need always maintain personal anonymity at the level of press, radio, and films."
    - This implies that a qualification for this position is that they are non-alcoholic.
    - This assistant will fill in when the alcoholic staff on the CPC assignment. What qualifications will the non-alcoholic assistant have to qualify them to work in place of the alcoholic staff member?
  - o Do we want a non- AA member as an administer of the LinkedIn page?
- "Not to say there is no "cost" for LinkedIn, but it is more in the realm of privacy compromised and data collection allowed. LinkedIn is currently owned by Microsoft
  - What is meant by "privacy Compromised"?

### Concluding remarks in background

- LinkedIn effort usurps what should be the domain of group members and local committees. "We have 1.5 million members US & Canada. (2019 GSC Report pg. 58) That should be an adequate resource to carry the message to professionals. If we show up and keep with our primary purpose of helping alcoholics, then we don't need to promote and professionals will respond accordingly."
- Regarding the need for more recommendations of Class A Trustees, "rather than depending on LinkedIn we should be improving lines of communication within the Fellowship to make members more aware of this need and how to answer it.

### SPOTLIGHT ON THE DISTRICT 09

District 09 is not the largest district in Area 74, but it is mainly in the largest county—Marinette County, along with portions of Shawano, Oconto, Forest and Menominee counties in Wisconsin along with Menominee, Michigan county. We use 17 locations for 37 meetings. We rotate our district meetings, held on the first Sunday of the month, to six different locations: Crivitz, Shawano, Oconto, Wausaukee, Suring, and Menominee, MI. Four of our six district meetings are over 100 miles—round trip—for me since I live in the northern end of our district. It is the same mileage for me to the meeting in Shawano as it is to Three Lakes.

I have some information as to our history. District 09 was started in 1974 with 4 members. Some of our "founding fathers" were Armond Z., Carl D., Bob W., and Dale K. who met in the basement of Faith Presbyterian Church in Crivitz. Average attendance grew to 8-12 members--with an Al Anon meeting alongside AA.

In Marinette one of our "founding mothers" was Germaine, one of the earliest females in AA. When she joined the Big Meeting Upstairs, she had over 60 years of sobriety and was an inspiration for many of us.

District 09 has held Intergroups and workshops. We have regular meetings in Marinette, Menominee, MI, Shawano and Oconto jails. We have been discussing hosting a conference, and we are the home of Past Delegate Sara P.

Even though we had no DCM during the last rotation, AA is alive and well and we look forward to a promising future.

### FROM THE AREA 74 FELLOWSHIP

Area 74 lost and old trusted servant this past March 1<sup>st</sup> 2020 John J. had fifty-eight years of continuous recovery when he passed. God gave John a great sponsor, Ande A. who had started his own recovery in 1941 gave John his livelong service to our Fellowship by taken him to Marquette Branch Prison. John often spoke of the warden and how he would come out before they would go to the meeting and say, "you're the best group in the prison" and shake everyone's hands. In 1961 when John started attending a local meeting which was two meetings every week called the Marquette county first group those two John later became a home group member of the same group which was changes to the Monday night "Questions and Answers Group."

On a personal note:

When I arrived in Marquette in 2003, I started to attend the Monday night "Questions and Answers Group." What I remember most about John was, he always had a huge smile, never having a complaint and if you would ask him how he was doing his response would be "better than I deserve." As I noticed more about him he would have his shoes off under the table. After learning chapter five and especially page fifty-eight, " if you have decided you want what we have and are willing to go to any lengths to get it then you are ready to take certain steps." I took those thoughts with me when John and I would go bike riding in the summer for three or four miles, stopping two or three times to talk and look at the beautiful scenery around Marquette. In the winter John would snowshoe in his back yard and I decided to join him but I didn't have the money at the time to buy snowshoes so he ordered them for me and said pay me back when you can afford to. I really respected that because I was able to spend more time with him. I also remember when there was significant snow fall he would ask me to break some trails.

John gave me some wonderful examples on working the program when my behavior was not in sync. With the spiritual nature I was trying to learn. I learned very quickly our code "love and tolerance of others should be our code. Over the years John gave me a spiritual program that makes my recovery stronger and to stay close to that loving God he spoke about so often. John was one of the most genuine individuals I ever worked with he was my go to when all the other sponsors were gone, he surely was someone that I will hold close to my heart for the rest of my life.

### **SETTING THE AGENDA**

Hello all members of Area 74. Hope this finds you being well and sober!

I have been contemplating writing this article for a while and hope it is taken in the spirit in which it is intended - to be informative and reflective, not to be misinterpreted as pointing out any shortcomings of any entities or members. Also keep in mind this is an opinion piece based on my experience in General Service which includes serving Area 74 and AA in many capacities over the last 20+ years.

It seems to me that we in Area 74 have lost sight of the process that 'Setting an Agenda' entails in the general service structure of Alcoholics Anonymous (AA). Area 74 does not fall into lock step with the General Service Conference (GSC) or the General Service Board (GSB) of AA, however, our Area 74 Guidelines do state "Ever mindful that the reason for the General Service Structure is to be of service to the fellowship of Alcoholics Anonymous, the Area shall always observe the spirit of the Twelve Steps, Twelve Traditions, and Twelve Concepts for World Service. In the absence of specific indications in the Guidelines of Area 74, the latest edition of the AA Service Manual may be relied upon." which to me infers that we generally follow the procedures used by the GSC. I was taken aback that one of the findings in the responses to the survey by Area 74 Ad Hoc Committee on Efficiency, Effectiveness, and Facilitation of Four Assemblies questions was that a majority of the respondents,53.3%, said the Area Chair should set the agendas for the Area Committee meetings not the Area Committee itself.

Setting an agenda for an Assembly is a process and does not just entail saying this is what time we are going to discuss a motion, when Standing Committee reports will be heard, what order are we going to hear Area 74 Conference reports, etc. The timing of meetings for the General Service Structure in Area 74 is designed around two main objectives -1. To be synchronized with the scheduling of the GSC and GSB, and 2. To be timely for helping the Groups to carry out their primary purpose of reaching the still suffering alcoholic. The following is a hypothetical illustration that will hopefully explain the process of how we are structured to come to a decision in fulfilling those objectives as far as our Area 74 Area Committee is concerned.

Let's say a Group comes up with an idea to have no more coffee at AA meetings in Area 74. (Ludicrous, right? But a pretty big decision effecting the health and harmony of Area 74). The Group would go to their District meeting and have a vote (group conscience) and let's say the finding was 8 in favor, 3 against, therefore passing with substantial unanimity. The District Committee Member (DCM) would then go to an Area Committee meeting and present the District's motion to the other DCMs and Area Committee members and give the background behind why the motion was presented. The DCMs would then return to their respective districts and present the motion and background to the groups there. The districts vote and it is found that 12 of the 24 districts in Area 74 were in favor, 5 against, 7 no opinion. The DCMs would then come back and confer at an Area Committee meeting and the consensus would be that there is enough interest in the motion to continue to explore the idea (50% were in favor), although it may need tweaking especially since a dozen districts, both for & opposed, thought it should only include no decaf be served not all coffee. Obviously, the motion has some depth and weight behind it but it needs some amending, so the DCMs go back to their groups with the results and the originating group decides to change their motion to exclude decaf only. The next Area Committee meeting would then 'set the item on the agenda' for the next Assembly as it is apparent the groups are ready to make an informed decision on this motion. There can be numerous outcomes at this point that are facilitated by the Area 74 Parliamentary Guidelines adopted from Robert's Rules of Order. But essentially the Area Committee had 'Set the Agenda' when it was apparent the groups were ready to make a decision. Sometimes the Area Committee can determine to 'set the item on the agenda' for an Assembly for discussion rather than a decision, but it is the full Area Committee that makes that determination.

Granted there were 3 Area Committee meetings and possibly 2 Assemblies before the Groups were ready to make an informed decision but most of the discussions and information had occurred prior to gathering for the vote at the Assembly. The Area Committee through the 'setting the agenda 'process had made sure the groups were informed, the motion and decision made, almost all questions had been answered prior to the Assembly, and a solid decision was determined by the Assembly of the groups through an informed group conscience.

Following this process may seem tedious but has served AA well for over 50 years (It took a while for the District structure to evolve since the founding of the GSC in 1950). This is how the Groups can be more engaged, the DCMs can have a real purpose to serve the Area Committee and the groups in their districts, communication with the Groups can be strengthened, and the health and harmony of Area 74 can be grown and fostered.

The Area Committee "Perhaps more than any other group of people in A.A., the area committee is responsible for the health of the Conference structure and thus for growth and harmony in the A.A. Fellowship". We have Standing Committees & Area Officers that have roles on the Area Committee to help carryout this responsibility and I believe we should re-vitalize the Area Committee to handle this responsibility. This does not mean to change the makeup of the Area Committee but re-focus its purpose. I believe the Area Committee has no real authority as that lies with the Groups through the Area 74 Assembly and GSC but it absolutely serves a very important purpose in Area 74. 'Setting the Agenda' is one of the primary ways the Area Committee should play its crucial role of communication between the Groups, the Area Committee, our Delegate, our Region, the GSB, and AA as a whole.

As we, together, follow the global developments related to the response to the COVID-19 (Coronavirus) pandemic, the experience, strength and hope offered by A.A. groups, Intergroups and Central Offices, AA Grapevine and La Viña, and the General Service Office has never been more evident.

The extraordinary effort taking place across our Fellowship is heartening in this truly difficult time: A.A. groups who are unable to gather at their usual locations are now meeting on virtual platforms. These virtual meetings have provided A.A. members, as well as those newly seeking help, the ability to connect with recovering alcoholics across the U.S., Canada and internationally – and stay sober one day at a time.

Local Intergroups and Central Offices are also providing support and resources to help A.A. groups navigate technology that might be unfamiliar to many members. In addition, some offices have developed "best practices" that have been helpful to a number of groups – especially those new to digital platforms. Although our physical doors are closed for the time being, the General Service Office continues to provide services to the Fellowship. Members can continue to download A.A. literature and service material from the aa.org website. We respond to nearly 200 letters a week from members in correctional facilities in the U.S. and Canada. Further, we are working around the clock to field the steady stream of national and local media requests, with the understanding that an accurate representation of our efforts can help members and others who might be struggling during this unprecedented period. There has been a lot of media coverage of A.A. in recent weeks.

As an important additional resource to A.A. members, AA Grapevine has provided free access to all 2020 Grapevine and La Viña stories, including the audio Grapevine stories.

Your groups' support and participation in the Seventh Tradition is always a fundamental element of the Fellowship, and is especially crucial now. It ensures that groups sustain good relationships with their landlords so that they have a place to meet once we can gather again, and it ensures that A.A.'s vital services continue. Shared experience reflects an increased use of the "digital" basket wherein groups and members utilize digital payment options for Seventh Tradition contributions to support the group and local entities. Many Intergroups and Central

Offices and Area service structures have added information to their websites about digital contributions.

For contributions to the General Service Office members can access the online contributions link on aa.org. You may also continue to send checks via standard USPS mail. Subscriptions to Grapevine and La Viña are available on the aagrapevine.org website, along with their other materials. Support is even more important given that revenue from literature sales has substantially decreased for the time being. It is clear that our shared efforts ensure that the hand of A.A. will always be there when anyone, anywhere reaches out. We thank you for your continued support.
