FROM THE AREA 74 ALTERNATE DELEGATE/ AREA CHAIR

Greetings,

Service work can sometimes be tedious and contentious, but it is a form of 12th step work that can bring spiritual rewards in the long run. Thank You to everyone that attended the online version of the Area 74 Assembly on 10-24-2020. I am not going to recap what took place at the meeting, that is what the minutes are for, but I would like to focus on how service work affects my recovery.

I noticed over a decade ago that when I went to a service meeting, whether it was for District 05 or for Area 74, that I always felt better after the meeting. I finally figured out that for me, the process of going to a service meeting was especially important to me. We usually carpooled to a meeting which led to long discussions on a variety of subjects. Most of the those subjects usually dealt with recovery in one way or another.

With the advent of the pandemic, that part of my service routine has been put on hold. Instead of meeting some fellow AAs in a parking lot at 5:30AM, I find myself sitting in front of my computer in my home office. That fellowship from the road trip is now missing. In April I found a way to replace some of the face to face fellowship that was a benefit to me. I started a conference call with some of the men that I sponsored, and we would discuss a selected speaker tape that we all had access to. The conference call was a good stopgap, but it did not replace that in person fellowship. Then the Zoom meetings started to become more prevalent, and as my sponsor said, "if we cannot meet in person, this is a good second choice".

So even if the Service meetings are on Zoom, it will still lead to 12th step work somewhere down the line. I am patiently waiting for the end of this pandemic so we can all meet once again, face to face.

MOTION on HOW WE DO BUSINESS

HISTORY

Currently Area 74 has scheduled 4 Area Assembles, 2 of them in conjunction with a Conference, and 3 Area Committee meetings. The Area committees will meet on an as-needed basis. The Assemblies that include the Area Conference will have speakers, workshops and a dinner dance. The Delegate will give their report at the 2nd Assembly, in addition to a Delegate Workshop before the General Service Conference. In addition, there can be Area Committee Meetings on an ad-hoc basis.

As pointed out in the CAB Revisited report by combining the Conference with the Assembly the people attending the Assembly do not have the opportunity to participate in many of the workshops, panels, speakers, and other activities because they are tending to business with the Assembly.

The combining of the Conference and Assembly was brought about by an Assembly motion in 20XX.

MOTION

We make the Following motion

- 1. The purpose of the Area Assembly is to conduct Area business. As such the Conference should be spun out as a separate activity apart from the Assembly.
- 2. The Delegate has the responsibility to schedule The Delegate's report as they see fit.
- 3. Area business would be conducted with 2 Area Committee Meetings, and 2 Area Assemblies per year, with the Area Committee Meeting being a 1 day event, and the Area Assembly being a 2 day event.

REVIEW

The Area Committee Meetings would take place in the 1st and 3rd quarter of each year. The Area Committee Meeting would consist of the Area Officers, DCM's, and Area committee chairs. The purpose of this meeting is to develop the agenda for The Area Assembly that is scheduled to meet in during the 2nd and 4th quarter of the year. In addition, they would pick workshop topics for the workshops that would take place Saturday morning of the Assembly.

The Area Assembly would consist of a 2 day meeting.

The Area committees would hold their meetings on Friday night. This will give a central location, and time for the Area committees, and a chance for everyone to participate in the Area committees.

Saturday morning would be dedicated to the workshops that were chosen during the Area Committee meeting. Saturday afternoon would be dedicated to handling the business of the area. This would consist of the Agenda items from the Area Committee meeting, and motions coming from the Area committee meetings that took place Friday Night, and any motions from the floor.

In the event of a Special Assembly (i.e. election assembly) we could forgo the workshops on Saturday morning, and replace these with the business session of the Assembly, and the Special part of the Assembly taking place on Saturday afternoon, or we can continue with the workshops in the morning, business session in the afternoon, and the Special part of the assembly in the evening.

SPOTLIGHT ON THE DISTRICTS

Warm Greetings from District 21!

District 21 has a unique rural location, spanning the northernmost range of Upper Michigan. We cover Houghton and Keweenaw counties, following the shores of Lake Superior all the way up the Keweenaw Peninsula. Copper Harbor, a town at the northern tip of the peninsula, is the literal end of US Highway 41, and is a popular tourist destination and photo stop.

We are home to two universities and serve a very diverse population.

At present, we offer 15 in-person meetings, 6 Zoom, and 2 "hybrid" or combination meetings. We also offer 2 seasonal meetings in the northern tip of the district. We have been very fortunate that our local churches have supported the recovery community and allowed meetings to resume, and a very dedicated core group of members came together as a Tech team to establish our website, <u>coppercountryaa.org</u> With things fluctuating due to Covid-19, the website provides the most accurate way to reach those seeking meeting information.

In normal times, our monthly District meetings rotate location quarterly, to balance travel time out for those attending. We now hold the meetings as a combination of in-person and Zoom, from a single location, to make it easy for all who wish to attend.

Our annual activities include various service-related seminars, hosting a traveling Intergroup event, a Spring women's retreat, and other informal District gatherings. We sincerely hope to resume these activities in 2021. In the spirit of outreach and service, our CPC committee continues to contact local medical sites, businesses, and other outlets for literature distribution. We have an updated meeting schedule printed in our local paper, and PSA's running on the radio with the local AA hotline number.

District 22 WI Door & Kewaunee Counties

Greetings Area 74 from the "Thumb' of WI, the peninsula that separates Green Bay from Lake Michigan. District 22 is approximately 90 miles long and a few miles wide and includes the cities of Luxemburg and Kewaunee to the south, Sturgeon Bay in the midsection, the northern towns and cities in Door County with Groups in Fish Creek, Sister Bay, Ellison Bay, and a Group with several meetings on Washington Island, our northern most point.

The Corona Virus pandemic has affected just about every one of the 25 or so groups (that have about 40 meetings in total) in the district. Most have been temporarily suspended from meeting in person and some have tried to maintain virtual meetings. Once the weather warmed, seasonal residents returned, and the logistics were worked out, some groups resumed trying to have meetings in outdoor settings. Some groups have tried to maintain a virtual presence through zoom but many of our groups are struggling to navigate this environment these days.

The District has held monthly meetings for the last two decades but for the last few years there has a been no DCM or attendance at Area 74 General Service meetings. The district has a Secretary, Public Information Chair, and Treasurer and maintains the doorcountyaa.org website with up to date information. The District meeting generally has 4-6 attendees including the officers, committee chairs, and a couple of GSRs – usually one from the Wash Island group!

Research by a member recently revealed that AA has had a presence in Door Co since 1946. There have been Groups in the two counties for 70 years and approximately 35 yrs ago District 22 was formed by splitting off from Dist 01 Green Bay. The fellowship here has been a bit 'off' this year with the pandemic and although the District participation has waxed and waned over time, the Groups and membership have been consistently strong in carry the message of recovery for decades.

Come visit us in District 22 for some fellowship and maybe even do a little 'touristing' when you do. May God keep you and Bless you until then!

FROM THE FELLOWSHIP

Returning to Our Primary Purpose

We believe that the Area Assembly as well as all the service structure needs to begin reducing its presence in AA. The Third Legacy needs to become more of a tail than the head. Our Area 74 needs to reduce its presence by limiting its responsibilities to carrying the Group Conscience message to New York, so that our groups can focus on staying sober once again by carrying the AA message to the still suffering alcoholic.

We have too much busy work. We need to get focused on finding and bringing prospects through the 12 Steps and teaching them the 12 Traditions. Few members are aware of this responsibility and fewer know how to carry that out.

We need one Area Assembly every other year to elect our Delegate and officers and One Area Assembly a year to vote on the GSC Agenda issues. We need one Conference every year for our Delegate to report on the GSC. We need to return to our primary purpose and not let our service structure become our Group Conscience. The correct balance is that the Group Conscience is the authority and the Service Structure is the humble secretary.

Since Bill W. passed back in January 1971, our Service Structure seems to be focused upon expanding. We have intentionally and unintentionally encouraged outside institutions, (like treatment centers) to do our 12th Step work for us. We need to mandate that New York stop doing anything until it hears from the Group Conscience (our Trustees have taken over the agenda for the GSC). As Alanon does with AA members, we should not allow anyone who is a member of Alanon to hold any service position in AA.

Our literature should not be carrying messages that are not coming from the AA program or following the AA Traditions. We need to not be reacting to current popular trends and political policies and we need to take our own advice, "Keep it simple," returning to our primary purpose. Our Area Newsletter probably needs to return to being published Now and Then rather than every month. We need to stop the trend of AA as "aftercare" for counseling programs and 12th Step these newcomers. We need to stop doing things until we hear from God (as expressed in our Group Conscience). We need to Keep It Simple!




