The jail meetings are still shut down and are not available for Zoom, as Officer Simcakowsi of the Wood County jail told me "we don't have the capabilities for that." She did like the idea though. We were informed by Daniel S. from District 03 that the Wood county jail was in need of some big books, a couple of our members agreed to look for soft covers that we could deliver. We are also implementing a plan to reopen a women's jail meeting in Wood county as soon as Covid restrictions are lifted, headed by three volunteers in two Districts.

Our district is looking into how we can reach younger folks and teens, to help in the alcohol addiction part of their lives. The idea is to talk with some church youth groups who work in detention centers with several counties around us.

We are on the Meeting Guide app, again I want to thank Dani and Lucas for all your service that made it happen. We are very much looking forward to their presentation at the Meeting Guide workshop on March 20th.

We have been busy with newcomers and returning AA's during the last year. Always we see a need for good sponsors. As Bob Darrell says, "the best way to change the culture of AA is through sponsorship."

A lot of our meetings have gone back to in person, we have no Zoom meetings that I know of. I've been reluctant to visit but I may reconsider soon. I continue to send out information via email to GSR's I have on file, there's rarely a response. I don't take it personal for I've seen our past two DCM's struggle to encourage participation at the District level.

Some of the positions are filled by same person as the district committee is small in numbers.

Area 74 AA Organization: The district members advise of the agenda items that occurs and does an overview of the agenda items as needed. Also reviewed and some items were discussed in the GSC agenda items for the upcoming months.

May 2022 Conference: The District 13 planned to put a bid in to host the May 2022 spring conference and was approved by the Area 74 Assembly.
