My name is Char and I am a grateful member of Alcoholics Anonymous. It feels like it has been too long since we were all together talking about how to help the still suffering alcoholic. It is good thing we have an Area Committee Meeting on Saturday August 7, 2021. This meeting will be held on a virtual platform. I really am not a fan of writing articles for the Now and Then. I have difficulty focusing in on the many thoughts that go through my head to make anything coherent. I like to share stories that have happened recently. I am not sure if this helps us get closer to a spiritual light bulb moment or not. I recently listened to an AA speaker -- live and in person. This was the first since February 2020 before we were limited in our gathering. I did not know this person and had no expectations other than how cool it was we were able to do this in a safe fashion. Anyhow, a point that the speaker made in sharing their story was asking about your priorities. They said something like carefully review the past three days and that will tell you where your priorities are. A very simple mind-altering task. My most time-consuming thing was my paid employment. The next was being a daughter and hanging with mom at the doctor's office among other things. Mom is fantastic! She had an amazing recovery from her experience. Thank you for all the prayers. I can tell I am getting older as these medical things that happen get me thinking about my own legacy. The next thing on my priority list was helping a drunk. Yes, helping a drunk. After 9.5 hours of paid employment and a service event on Zoom, I drove to pick up the last belongings of the person we helped move out of their apartment just a few days earlier. I keep telling those who helped in this person's journey, "that they will be rewarded in the kingdom of heaven". I then question my own judgement. Why are we helping a person who cannot make a decision if they want to live or die? The person asked for help. I was taught to say, yes. I am responsible when anyone anywhere reaches out for help, I want the hand of AA to be there and for that I am responsible.

Most people, I think, would agree with this reasoning in doing 12th step work. However, I am not sure the statement resonates with people regarding general service. We have heard the alibis. I am too busy. They argue about donuts. It is like a union meeting. They're going to do what they want anyway. My group's voice does not count when a single person can wipe out our group conscience. Perhaps we need to change the message that we need your help. I believe everyone should participate in general service at some point in their recovery. Service is the Secret.

FROM THE AREA 74 ALTERNATE DELEGATE/ AREA CHAIR

I hope and pray that everyone is doing well.

In the past I usually wrote about one of the principles or ideas that I learned in AA and how that principle or idea has been working in my life. Topics such as being of service, belief in a higher power, not being selfish, and I do not have to be right all the time.

Today I am writing about two specific items, one is an event, and the other is a procedure.

The event is the upcoming elections for Area 74. The date is 9-18-2021. The location will be Three Lakes WI and it will also be on Zoom. There will be numerous positions to be filled and we need to start talking about this now. Most of you who are reading this article are already involved in service in some form or another, and that is a great thing. As a group of servants, we can start talking about the Area elections, when it will be held, what positions are available, and how your recovery was enhanced by this type of service. For those who are already involved at the Area level it may be time to consider standing for one of the Officer positions. If you are not sure about that, talk it over with your sponsor or service sponsor.

The procedure that will need more consideration is the format of our service meetings. I have bought this idea up before and we still need to make a decision. Recently we have been meeting in "hybrid style" for the Assemblies. That means we met physically in Three Lakes and it was online via Zoom.

There has been an idea floated that the hybrid style Assemblies make the meetings more accessible and that will lead to more attendance. That has not been my experience. That last Assembly on May 15th there were 30 people on Zoom and 22 in person. If we continue to meet in a hybrid style we need to consider the implications, such as do we need a new position (Audio Visual Tech), what expense will be incurred, and how does this affect the budget.

Looking forward to seeing some of you at the Area Committee meeting on 8-7-21 via Zoom.
