District 13 Motion for Workshop/Sharing Sessions

Motion

Each Area 74 Officer, Area Committee Chair and available Committee Members plan and facilitate one Area 74 District workshop/sharing session per year, beginning in January 2023.

Background

Part of the scope of the Area Committee is to promote the growth and harmony of the Area.

Workshops/sharing sessions can better inform and engage District options to carry the message of recovery to the suffering alcoholics.

For the Officers and Committees to be proactive in supporting the Districts and Groups, this new policy will provide information and options to enhance engagement in reaching alcoholics locally and increase A.A. member involvement.

Currently having significant Area funds to facilitate thee events, the appropriate Committee budgets can be adjusted for consideration at a 2022 Area Assembly as presented by the Finance Committee.

The Area will cover the costs of these workshop/sharing sessions, including but not limited to travel, rent, supplies and lodging=(if necessary) .Assignments of which Districts each Officer/Committee will be responsible for can be charged to the Area Committee or other manner to be determined. Officers and Committee Chairs will communicate with the Districts they are assigned for date and location of the workshops/sharing sessions. The efficacy and adjustments to the policy will be evaluated at the April 2024 Area Committee Meeting and report to the following Assembly their findings. The goal of this policy is greater positive action and interaction between the Area servants and Districts to carry our spiritual message of recovery to the alcoholics not yet reached.

This motion of change in policy is drafted and supported by District 13 for the greater good of Area 74 service and 12 step opportunities.

TITLE: District 18 - <u>Area 74 to spend Area Contributions within the Area</u>

Background Material

The groups in District 18 have been discussing the Area 74 contribution of \$5,000.00 to G.S.O. for a year now. Initially the discussion centered around the contribution itself. Could the Area contribute to G.S.O.? According to the Service Manual the Area can contribute to G.S.O.

Service Manual - Chapter 10 The Board's Operating Corporations. Section A.A. World Services, Inc. In this section there is a heading FINANCIAL SUPPORT. In the fourth paragraph there is a sentence which states: "In keeping with the Seventh Tradition, G.S.O. accepts contributions only from A.A. members, groups or other A.A. entities (for example, delegate areas, districts, A.A. Conventions, A.A. Roundups, Intergroup/Central Offices)." Then it became about the groups intention for contributing to the Area. The groups intended for their contribution to be used for Area Business. Which is not what happened. As a result of the statement below we do not think the Area should send group contributions to G.S.O. If G.S.O. felt the need for financial support, they would notify the groups about the issue.

SM F-196 "If a situation arose where the expressed need could not be met by G.S.O.'s resources alone, we would contact local A.A. groups and ask for additional help. This has not occurred to date."

In the Area 74 Guidelines it is already stated that the Treasurer will issue checks for the expenses of the Area. This motion would be more specific about the distribution of the group's contributions. 



The Preface to the Second Edition of the Big Book explains that revisions to the personal history section of the book were made in order "to represent the current membership of Alcoholics Anonymous more accurately, and thereby to reach more Alcoholics." In that spirit, the 2021 General Service Conference recommended that "a Fifth Edition of the Big Book, *Alcoholics Anonymous*, be developed, including an update of stories to better reflect the current membership, keeping in mind the 1995 Advisory Action:

"The first 164 pages of the Big Book, Alcoholics Anonymous, the Preface, the Forewords, 'The Doctor's Opinion', 'Dr. Bob's Nightmare", and the Appendices remain as is."

In response to the 2021 General Service Conference Advisory Action requesting the development of a Fifth edition of the book *Alcoholics Anonymous*, the trustees' Literature Committee is seeking a wide range of A.A. recovery experience of members in the Fellowship.

The trustees' Literature Committee is searching for recovery stories of our members for possible inclusion in the Fifth Edition which are from a broad cross-section of our local communities, all stories are of value. As Bill writes on page 29 of the book Alcoholics Anonymous: "Our hope is that many alcoholic men and women, desperately in need, will see these pages, and we believe that it is only by fully disclosing ourselves and our problems that they will persuaded to say, 'Yes, I am one of them too; I must have this thing."

It is the Literature Committee's shared hope that any new stories from our current membership will help future alcoholics to identify and find recovery in the pages of a Fifth edition.

The suggested format for typed manuscripts is 3500 words, double spaced, in 12-point font. Handwritten manuscripts should be approximately 5 to 6 pages. Please include your complete name, address, and email/phone information on the first page of the submission. A copy of your manuscript should be retained for your files.
