72[∞] General Service Conference Report for Area 74 4-24-2022 through 4-29-2022 Presented at the Spring Assembly in Ashland WI 5-21-2022

I want to Thank Area 74 for having the confidence in me to send me to the 72⁻⁻⁻ General Service Conference. As I recount what I saw, felt, and heard I will miss an item or two. The experiences and emotions were hitting at a lightning pace with very little time to process.

Everyone at the Conference loves AA as much as I. I cannot image anyone would endure the pace and sustained energy of the Conference week unless they did. There are some that let their opinion on matters that do not necessarily relate to recovery get vocalized when they come to the microphone, but those are a small percentage.

This first segment of my report is devoted to a running narrative of my overall experience at the General Service Conference. The next segment will be a review of the Committee Reports and the Advisory Actions that resulted (those Recommendations and that passed), followed by the Considerations. The last segment will be the Floor Actions.

I arrived on Saturday the 23rd

The Conference officially started on Sunday the 24th, but there were non-conference events scheduled. Those events are included in the attached document "Conference Week Schedule"

Checked in and went right to the Hospitality Meeting. Mostly just walking around and introducing myself. The next scheduled event I attended was the pre-conference 1728 Meeting. The name of the meeting is derived from 12*12*12. The 1728 Meeting started as a way to introduce non-AA conference members, such as Class A Trustees or non-alcoholic General Service Office workers, to the principles interwoven into the Program of Recovery outlined in the book Alcoholics Anonymous.

The next event was the Remote Communities meeting. We had Presentations and discussions centered around three related topics.

- 1. What are the challenges/solutions to carry the AA message to a Geographic Community?
- 2. What are the challenges/solutions to carry the AA message to a Linguistic Community?
- 3. What are the challenges/solutions to carry the AA message to a Cultural Community?

Earlier in the day the Chief Financial Officer was tasked with looking at the makeup of the remaining voting members to ensure the percentages of participating members were still in line with the vision set forth by the founders. His numbers were:

Delegates 83 69.2% Trustees 25 20.2% Staff 12 10.0%

The end of the day was a Delegates Only meeting Chaired by the Delegate Chair, Pam K, Delegate Area 39, Western Missouri. This was another time for "getting to know each other". The Panel 71 Delegates shared some of their experience from the previous year. There was a lot of talk on how different it was not being in person. The overall feeling was they were glad to be meeting in person. Quite a few Delegates mentioned that their home Areas were upset over some of the decisions, but all that spoke stated that each Agenda items was thoroughly discussed and that a solid group consciousness was reached for every decision. We were instructed not to discuss any business until we are in our Committees or in session on the main floor.

4-24 Sunday

The opening session started at 900 am and Linda Chezem, Chair of the General Service Board, gave the Welcome. The roll call was completed by Bob W, the General Manager of the General Service Office. The roll call itself was an emotional event for me. At that point I really felt the obligation to make the best decisions possible for AA as a whole. The total voting Conference membership was 133.

We had a working lunch with each Region meeting in their own room with their Regional Trustee. If we had any questions or concerns, we could ask the Cathi C, our East Central Regional Trustee. The East Central Region consist of Wisconsin, Illinois, Michigan, Ohio, And Indiana. There are 14 Delegate Areas. As a group we purchased an engraved clock for her and Cathi had purchased a little Statue of Liberty for each of East Central Regional Delegates.

After lunch we met in the main conference room and the General Manager, Bob W, gave a presentation on the mechanics of the Conference. He after reviewing a set of procedures we practiced using the electronic voting device to agree to those procedures. How the conference operates is very similar to how we agree to run the service meetings in Area 74.

We then had a presentations on REDELA(Meeting of the Americas) Online based meetings from the north pole to the tip of south America. REDELA is an acronym for Reunión de las Américas. The report was given by Marita R, Trustee-at-Large/U.S. The takeaway for me was there is still a lot of work to be done with a majority of that work being related to remote communities.

At 400 pm The Conference Committee on Agenda met for the first time. (which is the Committee I was randomly assigned too). The Conference Committees are composed of Delegates along with one GSO staff member being assigned as the secretary. From the 71st Conference there was already a Chairperson in place, Beth P from Colorado, and she ran the meetings. We met briefly with the Trustees General Service Conference Committee, there was some discussion on the unintended consequences of the Equitable Distribution of Workload Advisory Action. Then we started discussing the Agenda Items for our Committee. Those items will be reviewed during the next segment of my report.

The evening was consisted of the Opening Dinner and AA meeting. It was a sit-down meal that filled the conference hall, followed by what each of us would recognize as an AA meeting. Four conference members shared a short version of their story. The person I remember best was Jon W, Senior Editor for the AA Grapevine. I met him earlier in the day and he seemed like a quiet and unassuming individual. Then he told his story which included being a drummer in an 80's club band in New York.

4-25-2022 Monday

The morning was entirely Conference Committee work. The afternoon session started with the General Service Board Report by Linda Chezem, Chairperson GSB, then the AAWS Board Report By Jimmy D who is the AAWS Board Chair. Then the AA Grapevine Board Report by Josh E Chair of the Grapevine Board,

Then finally the Finance Report by Kevin Prior, NonAA General Service Board Treasurer. All the Board reports and the Financial PowerPoint presentation will be included in the electronic copy of this report.

The end of the night was a general sharing session, no specific topic. You could ask a question, bring up a new idea, or just vent. I do not have any notes on what was said.

4-26-2022 Tuesday

The morning session was once again devoted to Committee work followed by some presentations in the early afternoon. Three Panel 71 Delegates presented on the following subjects;

Tom W, Area 15- How do A.A.'s go to any lengths to Recover, Unify, and Serve?

Sheryl T, Area 69- Going Beyond Fear

Gordon N, Area 21- How to Reach Anyone, Anywhere

Midafternoon was a presentation called "Participation of Online Groups in the US/ Canada Service Structure" by Trish LaN, Trustee at Large Canada. There is still a lot if information that needs to be gathered and some more questions that will need to be answered before a definitive plan can be worked out about how the online groups will fit into the service structure. The Trustees Ad Hoc Committee will continue to meet and report back next year.

Then I asked a question about the number of new online groups vs. the number of existing remembers.

Are we just redistributing the membership? Do some online members belong to a physical group? There is no answer to those questions yet, but the Trustees will be looking into that.

We then moved into a presentation on the 6 warranties contained in Concept 12.

This type of presentation was helpful in the sense that it reminds the Conference of how we are supposed to be acting.

The end of the day was a Delegates only dinner. The focus was to feel more comfortable with other and to elect a new Delegate Chair for the 73⁻⁻ GSC. As part of the process, I would sit with a different group during the lunches and dinners. That process helped to broaden my understanding of the conference experience and put what we are trying to do in context. When I sit with Delegate from Yukon Territories one day and then sit with the Delegate who lives in the desert southwest near Santa Fe, my viewpoint changes.

Wednesday April 27

The final session of my Agenda Committee work lasted until noon. Our work was completed but there were still some Committees that need some more time. Some had to worked through their lunch or meet early before the Conference to complete their report.

The afternoon General Session was focused on the Election of the Eastern Canada Regional Trustee, and the Pacific Regional Trustee. The third legacy process was used and one of the elections went to the hat.

After the Elections we got into the meat of the Conference process. The General Manager Bob W reviewed "How the Conference Operates and read a list of procedures that we all agreed to follow. Each Committee Delegate Chair was tasked with giving a report to the Conference. The Committees are as follows:

Conference Committee on Agenda

Conference Committee on Cooperation with the Professional Community

Conference Committee on Corrections

Conference Committee on Finance

Conference Committee on Grapevine and La Viña

Conference Committee on Literature

Conference Committee on Policy/Admissions

Conference Committee on Public Information

Conference Committee on Report and Charter

Conference Committee on Treatment and Accessibilities

Conference Committee on Trustees

These reports contained the "Recommendations", which are the agenda items that were to be voted on. Once the report is red into the record, The Chair, which alternated between Linda Chezem (Chair of the Board of Trustees) and Bob W(General Manager of the GSO) ran the meeting This is when discission and the voting commenced. The Committee reports are attached as an Appendix.

After the Dinner break then we continued with the Committee reports and voting.

At 9:47 pm we stopped that session of the Committee reports and voting to start a general sharing session. I went to the microphone and asked if there was an overall flowchart of the workload and projects, and if so, how do we get a copy? A class A Trustee, Carolyn Walsh, approached me and after the session and she stated that she had asked the same question at a Trustees Board meeting. She had a copy of a differed projects list, and she would email it to me. She also requested that I do not distribute this list as it may be taken out of context. I said I would honor that request. The reason for my question was, have we, AA, passed so many Advisory Actions that we do not have the money or resources to get all the projects completed. And that seems to be so.

Thursday April 28th

Thursday morning it was announced that four voting members had been quarantined. The Chair stated the Tech Team was looking into options for the quarantined members. The Chair asked for a sense of the body if we should keep looking into options. The body was in favor. The tech Team was able to send an Audio feed to those quarantined in their rooms. The process was not interactive but he Members that were affected were very appreciative.

The majority of the day was devoted to Committee Reports and voting. At 8:45 pm we took a 15-minute break and came back for a General Sharing session. I went to the microphone and shared that Area 74 had a concern about the total number of Agenda Items and the volume of associated background material. I specifically mention that one group had sent me a letter specifically stating, "Area 74 reject the entire Conference Agenda!" and that letter was also published in our Area Newsletter.

We closed the meeting a 0930 pm.

Friday April 29th.

The Opening Session started at 830 am. Two floor motions were submitted at the opening of the session. All the floor motions that were submitted will be considered at the end of regular business and in the order that they were submitted.

More Conference members were reported to have tested positive. Members were randomly testing themselves and plenty of test kits were available.

At 1115 am we had a presentation that was moderated by Jimmy D, the AAWS chair and the presenter was David R, the publishing Director. Some of the takeaways that I Put in my notes were:

- 1. All the electronic versions are in addition to, not replacing printed text.
- 2. More tablets being issued to prisons and reports are getting better.
- 3. Print sales for hard cover books are up worldwide. The printed word is not fading.
- 4. 73 languages for the Big Book, 111 languages for rest of out literature

The afternoon session started out with another floor action and then went into the remainder of the Committee reports. The last segment of the General Service Conference was the devoted to the Floor Actions that were submitted over the course of the Conference. There were nine Floor Actions that were submitted and had a second.

At the beginning of the nine floor actions, we had 120 out of the original 133 voting members present.

At 8:50 pm we concluded the debate and voting on the nine floor Actions.

Closing Statements

Since being elected Delegate Servant I have heard a lot of comments about change- "they just want to change the program little by little", It is a slippery slope if we start to change this" They want to take "GOD" out of the program"-"This is an outside issue". My experience at the 72⁻⁻⁻ General Service Conference is that everyone there has a deep-seated love for Alcoholics Anonymous. The amount of effort it takes to endure the Conference week is fairly substantial. My conclusion is no one in their right mind would sit thru the entire conference unless they were devoted to Alcoholics Anonymous.

After the last floor action was voted on each of the outgoing Delegates made a short 2-minute farewell, this was followed by the closing remarks of the Chair of the General Service Board, Linda Chezem. Then Serenity Prayer was recited in French, Spanish, and English. The entire room stood silent for a few seconds, then the crowd started to move around. I started to cry, then I notice there where a lot of people with tears. I tried to talk to the Delegate who sat behind me but I found I was all choked up and could barely get any words out of my mouth. He was the same way. It was one of the more moving experiences I have had.

I truly am thankful that I could participate in such an event. Thank you ALL.

The Preface to the Second Edition of the Big Book explains that revisions to the personal history section of the book were made in order "to represent the current membership of Alcoholics Anonymous more accurately, and thereby to reach more Alcoholics." "The first 164 pages of the Big Book, Alcoholics Anonymous, the Preface, the Forewords, 'The Doctor's Opinion', 'Dr. Bob's Nightmare", and the Appendices remain as is."

In response to the 2021 General Service Conference Advisory Action requesting the development of a Fifth edition of the book *Alcoholics Anonymous*, the trustees' Literature Committee is seeking a wide range of A.A. recovery experience of members in the Fellowship.

The trustees' Literature Committee is searching for recovery stories of our members for possible inclusion in the Fifth Edition which are from a broad cross-section of our local communities, all stories are of value. 


