73nd General Service Conference Report for Area 74 4-23-2023 through 4-29-2023

Presented at the Spring Assembly in Green Bay WI 5-20-2023

I want to thank Area 74 for having the confidence in me to send me to the 73rd General Service

Conference. As I recount what I saw, felt, and heard I will miss an item or two. And just like last year, the experiences and emotions were hitting at a lightning pace with very little time to process. This year, at the Conference, we often went late into the evening to complete the work we were sent to New York to do. The following documents are also made part of this report:

The first segment of my report will be a summary of the events as it relates to the resignation of Linda Chezem, past class A Trustee and past Chairperson of the General Service Board of Trustees. The next segment will be a running narrative of the Conference week containing my experiences. Then a review of the Conference Committee Reports and the Advisory Actions that resulted, a review of the Floor Actions, and then a review of Financial PowerPoint Presentation. (if there is time I have some pictures to share)

On January 29th, Linda Chezem resigned as a Class A Trustee and the Chair of the General Service Board, a letter to the fellowship, dated 3-3-2023 was then sent out to the fellowship. Shortly after Josh E, a Class B Trustee resigned. Three online question and answer sessions were eventually scheduled, 03-16-2023, 03-30-2023, and 04-13-2023. Another letter dated 03-16-2023 was sent to the fellowship. After the second Q and A session I called our East Central Regional Trustee Cathi C. I asked her if at any time had she ever felt bullied or coerced, she stated no. There was a Delegates only monthly meeting that was scheduled near the beginning of each month. Near the beginning of April, a poll was sent to the

delegates requesting Linda Chezem be invited to the April session of the Delegates only meeting. The response to the poll was 40 yes and 40 no. The organizer of the poll then withdrew the request. Another delegate then sent out a Zoom Invitation for a meeting with Linda Chezem on 4-10-2023. I was

only able to attend the first 30 minutes of that session. After all the meetings and some personal discussions at the GSC, my overall impression is the General Service Board could have handled the situation better and their intent was to protect Linda Chezem's reputation. My opinion is not shared by all of the voting members of the General Service Conference. This entire situation generated some floor actions and will be discussed later in this report.

I arrived on Saturday, 4-22-23

The Conference officially started on the 23, but there are ancillary meetings that occur "outside "of the Conference. The first meeting I attended was the Delegates Only meeting in the evening. This was an opportunity for the 72nds to share some of their experience from last year and give the 73rds a chance to ask questions. *Sunday*, *4-24-23*

The opening session started at 900 am. The welcome was given by the interim Chair of the General Service Board, Jimmy D. Bob W, the General Manager of the General Service Office, presided over the roll call. A floor action to suspend the Agenda and have discussions on three topics was introduced. A vote to table the motion was taken, 88 yes and 12 no. The reasoning was to have the Agenda Committee caucus over lunch and follow the existing conference committee procedures(I am on the Agenda Committee). After Lunch the Agenda Committee submitted the following

Consider request to suspend reading the Area Highlights from the 73rd General Service Conference and include in the 2023 Conference Final Report, to allow discussion.

The Conference committee on Agenda recommended that the reading of the Area Highlights from the 73rd General Service Conference be suspended and included in the 2023 Conference Final Report, to allow discussion of the following topics:

- Are the decisions of the General Service Board producing Unity within the Fellowship and inspiring confidence in the Board's future functions?
 - The General Service Board Code of Conduct
 - Is the prudent reserve being used as the Conference intends?

At 1:15 pm the motion was brought back off the table displacing the scheduled Area Service Highlights. Each first year Delegate is given 2 minutes at the microphone to speak about their Areas. This helps the first-year delegates to feel more at ease in front of the Conference. No decision was reached, and the session ended at 2:45 pm. The next available time to debate was on Monday at 1:30 pm. The existing schedule was followed the rest of the day.

The Opening dinner and AA meeting started at 6:30 pm and my wife was in attendance. As part of the obligations of the Alternate Chair for the Agenda Committee, it was my honor and privilege to chair the meeting and introduce the four AA speakers that gave a 10-minute version of their stories.

Monday 4/24/2023

Monday morning was the start of the Big Book Translation Reading room. Each member of the Conference was assigned a time before the Conference started for the day, to read draft chapters of the translation. The first five chapters were complete. More on this later in the report. The entire morning was devoted to Delegate Conference Committee work. There are 13 Delegate Committees that meet during the conference. From these Committees come the recommendations and additional considerations. The recommendations are discussed and voted on in the business sessions, if a recommendation passes it then becomes an Advisory Action. When the additional considerations are presented to the Conference, you have the opportunity to ask questions, but no debate is allowed. In the afternoon, the motion that was introduced on Sunday was brought back on the table. That motion eventually failed. For the rest of the afternoon and evening the following were presented, GSB Report Summary, AAWS Board Report Summary, AA Grapevine Board Summary, World Service Meeting Report, and the Finance Report. I will review the Financial PowerPoint presentation later in the report. The last session of the day was a General Sharing Session that ended at 1000 pm, I think.

Tuesday 4-25-2023

Tuesday morning was devoted to Delegate Conference Committee work. There was a trip planned to visit the General Service Office for the afternoon. I did not attend and took the opportunity to take a walk, then review some of the Agenda Committee work in case there were questions asked later in the week. Some of the Committees took that time to finish their work. From 600 pm to 700 pm was the Delegates only dinner and meeting. The new Delegate Chair waselected and Delegate mail person.

The Evening session started at 800 pm and it was entirely Area Highlights. All the Delegates were able tohave their 2 minutes at the microphone.

Wednesday 4-26-2023

On the Agenda it states, "Committee Reports and Discussion", that is the time when the Chair of each induvial Delegate Conference Committee reads their reports. Each recommendation in the report is then discussed and voted on. If approved, the recommendation then becomes a Conference Advisory Action. That first session went from 900 am to 1200 pm.

After lunch the following Trustee elections were held:

Northeast Regional Trustee Ken T., Area 30 (Eastern MA)

Southwest Regional Trustee Teresa J., Area 46 (New Mexico)

Trustee-at-Large, Canada Robert L., Area 89 (NE Quebec)

I did not participate but stayed in the room to observe the process.

The evening was broken into two sessions, the first being a General Sharing Session and more

Committee Reports and Discussion.

Thursday 4-27-2023

In the morning before the start of the conference session, it was my turn in the reading room for the Draft of the Plain Language Translation of the Big Book. We had an hour to read, all electronics had to be left at the door, and we could use the paper provided to take notes. The hour went by very fast and I only got to the story about jay walker. Friday afternoon there was a 2-hour time slot set aside to discuss the project. More on that later in the report.

The morning session was more Committee reports and discussion. The afternoon started out with three presentations and then back to the Committee reports. After Dinner more Committee Reports and a General Sharing Session. We closed the session around 1000 pm.

Friday 4-28-2023

The morning started with Committee reports and Discussion. At 11:15 there was a report on the Participation of Online groups along with a discussion. The issue is still evolving, and any experience or ideas are still welcome.

After Lunch the Plain Language Big Books discussion took place. At that point in time, all the Conference members were given the opportunity to review the completed draft chapters. As stated earlier, I only reviewed up to the story of the jay walker. I took notes and they will be included in my report.

My impressions and notes:

Forward is more of a history, and this is not to replace the book Alcoholics Anonymous.

The original Dr's opinion is laid out side by side with the translation.

God is still in the Book.

Ebby to Bill- "create your own idea of who- or what- God is?"

Javwalker is a she.

During the open discission there were comments like" My Area was against it but now that I read it, I think it has value", "God is still all over the book", all the French and Spanish speaking Delegates made comments about how this will help. During the discussion I kept an unofficial tally of those that came to the microphone, 33 were in favor and 3 were opposed. There were some suggestions stated at the microphone (see below) and everyone was encouraged to send any suggestions to the Plain Language Translation Subcommittee:

- -make the book a different color
- -make the book a different size
- -do not use "Big Book" in the title

The discussion took 2.5 hours

Eventually we took a break for dinner. Once the final Delegates Conference Committee Report was given and the recommendations voted on, the Floor Actions were introduced. After the Floor Actions were disposed of, we transitioned into the farewells by the outgoing Delegates. It was agreed that,

instead of 2 minutes at the microphone, it was reduced to 1 minute. By the time I got back to my room itwas 1:24 am.

Saturday 4-29-2023

There were three Class B Trustees that were rotating out:

After breakfast the three Trustees gave their farewell talk

We adjourned at 1030 am.
