#### **Ask The Delegate:**

During my term as Delegate, I will share with you, the Fellowship of Area 74, questions that I get asked each month and my reply. I believe that if one person, group, committee has that question, others will as well.

"What did you think of the Plain Language Big Book?"

I would love to come to your Group, District, or Committee to share with you not only my experience with reading the book but some of the comments made during the 10-hour discussion on the book. I will summarize my experience. The book moved me to tears and while reading it the thought came to me "this is the language of the heart, what is written in this book is what I say to sponsees and what I hear in meetings." I also felt that the book seemed to have more God in it. Rather than the multiple and variety of expressions that the 1st 100 used to describe God, the new book uses 2 expressions – God and Higher power. Additionally, each time God is referred to as him has been translated to God. For example, in How it Works the line says, "may you find him now" – the translation says, "may you find God now." Time will tell the impact this book has and although no time frame has been set and I predict that it will be available in late 2024 or early 2025.

A DCM asked, "I have a group that wants to kick a member out for being disruptive, what can I do?" These questions are always tough. I believe strongly in group autonomy and the groups' right to be wrong listed in our traditions. I encouraged this DCM to have a conversation with those in the group that are wanting support in the removal to get to the root of the issue. I suggested a reference to our traditions and concepts. I suggested that if the group took the action that the DCM could also follow up with the AA member and see if the DCM can guide them to another meeting or group. We recently had a situation in my home group where a member's behavior became a bit concerning and one of our home group members just gently asked him if wanted to have a chat outside and they casually left. Our General Service Office is a wealth of experience on many topics related to safety and membership concerns from many years.


