The **purpose** of these summaries is so that they may be used as a tool by General Service Representatives (GSRs) to provide their group with pertinent information to facilitate an informed group conscience and then to convey that group conscience to the Area 74 Delegate. In many cases, the summaries serve as an appetizer and those GSRs and groups with an interest in more information can obtain the complete background by way

Please remember to **treat the background as confidential**, and do not share it in any public forum or with non-AA members. This is because the background may contain first and last names of AA members, their emails, their addresses, or other personal information.

Please pay special attention in these summaries to the section at the end of each topic: "What does the Delegate need to know?" Not all topics make for fruitful discussion at group level, and this is intended to help you narrow that down. Many of the agenda topics are only for that specific committee (such as reviewing a draft or progress report on the development of a piece of literature) and do not require a group conscience, but they still may be of great interest to read and share. Other topics appear every year, such as reviewing workbooks and kits used by Public Information, Corrections, etc. Local committees may wish to share their experience. These summaries may also be used by other members of our Fellowship to communicate valuable information about the agenda topics and, where appropriate, to convey opinions to the Delegate. The questions in this section, if any, are intended to be a guide, not a limit, for your sharing sessions. Feel free to interpret them broadly.

During the Conference, proposed changes include an earlier start

time, additional sharing sessions, and more flexible dining options. After the

Brunch.

Historical Context; Why is it on the Agenda?	At the July 2024 quarterly meeting of the General Service Board (GSB), the chair of the trustees' Nominating Committee appointed a subcommittee to develop a process for handling grievances related to GSB actions. The subcommittee was tasked with researching A.A. history, recent experiences, and aligning the process with the GSB bylaws, Conference Charter, Twelve Concepts, and Twelve Traditions.	
	The Agenda background includes a report on their efforts and a proposal for a "Harmony and Effectiveness Session" at the General Service Conference. The proposed session, led by the General Manager of the General Service Office or the Chair of the GSB, would provide a space at the General Service Conference to discuss grievances, barriers to unity, and communication. The proposal suggests holding this session for three years at the 76th, 77th, and 78th Conferences.

Historical Context;	In 2017, the Conference CPC committee began exploring the feasibility of

Agenda?	Community efforts. The trustees were asked to assess whether this would

align with A.A. Traditions and to develop an implementation plan. In 2018, the trustees presented their findings, and the Conference CPC committee recommended launching an A.A.W.S. LinkedIn page to help professionals find information about A.A., expand the reach of the *About A.A.* newsletter, and potentially attract Class A (non-alcoholic) trustee candidates. The 2019 committee reinforced this request, adding a disclaimer clarifying that "promoted" content was not affiliated with A.A., suggesting links and content on A.A.'s cooperation with professionals, and requesting an annual usage report. As of September 30, 2023, the LinkedIn page has 3,261 followers, 2,344 total page views (up 2.7% from last quarter), and 872 unique visitors (down 5.6%). Current priorities include posting newsletters, videos for professionals, employment opportunities, and increasing A.A.'s visibility on LinkedIn. CPC — Item B

Review progress report on the development of outward facing pamphlet for mental health professionals.

Historical Context; Why is it on the Agenda? In 2021, the Conference CPC committee recommended developing a pamphlet for mental health professionals. By October 2023, interviews with mental health professionals were completed, and the gathered materials were forwarded to the AAWS Publishing Department. This information, along with existing A.A. literature, will be used to create a draft pamphlet. In January 2024, the trustees' Committee on Cooperation with the Professional Community/Treatment and Accessibilities (CPC/TA) reviewed the pamphlet's progress, including a working title and plans for a follow-up meeting in July, where AAWS Publishing will provide another progress report or a draft of the pamphlet.

Review content and format of C.P.C. Kit and Workbook.

Historical Context; Why is it on the Agenda? Kits and workbooks for CPC, Corrections, Public Information, and Treatment and Accessibilities are reviewed annually by the appropriate trustees' committees. Service kits are typically updated each fall. Click on the links to read the CPC Workbook and content list of the CPC Kit.

Review progress report on the effective use of CPC videos on aa.org.

Historical Context; Why is it on the Agenda? In October 2023, trustees discussed updating CPC videos available on aa.org targeted at professionals, considering content, cost, and other factors. They highlighted the need to refine the language to better address both professionals and those in supporting roles. In January 2024, they reviewed a proposal to revise three CPC videos currently on aa.org and requested

	replacing the term "pre-professionals" with para-professionals" to better reflect those who work alongside professionals. The estimated production cost is \$3,000 for editing (with six rounds of revisions), \$2,000 for stock music, and \$1,000 for translation. Corrections — Item B

Review progress report on development of a pamphlet on the transgender alcoholic in A.A.

Historical Context; Why is it on the Agenda? In 2021, our Area (CNCA 06) requested that a pamphlet entitled "Experience, Strength and Hope: AA for the Transgender Alcoholic" be produced. The Area passed this proposal by substantial unanimity after multiple years of discussion. This proposal began at Queer Femmes: A Meeting for Trans Women and Queer Femmes of All Genders, a group in Oakland, CA, was forwarded to the District, where discussion occurred for the better part of 2018. The proposal was then forwarded to the Area, which discussed the proposal for two years until the motion to forward the request passed In 2024, the Conference approved the motion with substantial unanimity. An announcement was distributed to the Fellowship in February 2025, seeking stories from Transgender A.A. members with an April 15, 2025, deadline date. It is anticipated that a working group or subcommittee will be formed and that an updated report will be provided to the 2026 General Service Conference.

Corrections — Item C

Review Data from Tablet Vendor Edovo.

Historical Context; Why is it on the Agenda? The U.S. prison system has increasingly shifted from print media to tablet devices for accessing literature. A major vendor, Edovo, provides thousands of these devices, allowing incarcerated individuals to access A.A. eBooks. The background includes data on available A.A. eBook titles and engagement levels. 19 correctional facilities in our area (Area 06) offer A.A. literature through Edovo, with 2,771 recorded instances of literature being read, though no specific timeframe was provided for this data.

Corrections — Item D Review Corrections Survey

Historical Context; Why is it on the Agenda? In 2024, the Conference Committee on Corrections requested shared experience on how local corrections committees encourage members to participate in Corrections service. (In our Area, corrections service falls under the umbrella of the H&I Committees of Northern California.) On October 3, 2024, a survey was distributed in English, French, and Spanish to Delegates, Area and District Corrections Chairs, H&I Coordinators, Bridging the Gap (BTG) Chairs, and A.A. groups active inside correctional facilities. The survey closed on December 16, 2024, with 759 initial responses, 460 of which qualified for inclusion. The full survey results are available in the background material.

Historical Context; Why is it on the Agenda?	This Agenda Topic asks delegates to reaffirm a 1975 Advisory Action that encourages groups to consider the impact of inflation on their contributions and adjust them accordingly to support A.A. services. The background includes a report from the trustees' Finance Committee emphasizing the importance of educating groups on self-support and the rising costs of A.A. services.
What does the Delegate need to know?	Does your group feel it is still necessary to encourage groups to adjust their contributions in response to inflation? Why or why not? What more can be done to educate members on the impact of rising costs on A.A. services?

Historical Context; Why is it on the Agenda?	Areas are asked to voluntarily contribute a minimum amount toward each Delegate's expense for the General Service Conference. Since 2005, this minimum has increased from \$1,200 to \$2,200, while the total cost per Delegate now exceeds \$9,000. Areas may vote to contribute more than the minimum. The background includes a history of delegate expense contributions, current costs, and how expenses have changed over time.

The background includes a history of bequest limits and past Conference decisions on maximum contribution amounts.

Historical Context; Why is it on the Agenda?	This Proposed Agenda Item (PAI) was submitted by a GSR from a Spanish-speaking group in Area 09. The background contains the PAI submission form where the GSR raises concerns that the Service Manual's language may allow a group to deny a GSR's right of participation, potentially discouraging interest and engagement in General Service. The GSR emphasizes the essential role of A.A. service and trusted servants in keeping the Fellowship informed.

What does the Delegate need to know?	Does your group think this section of <i>The A.A. It now includes shared experience on using Grapevine and La Viña as recovery tools, colorful illustrations, clickable links for easy navigation, and a design that allows for periodic updates. A Spanish version is also available on the La Viña website.

Review the five-year financial plan for La Viña.

Historical Context; Why is it on the Agenda? La Viña was launched in 1995 following a Conference Advisory Action recognizing the need for a Spanish-language edition of Grapevine. The Conference approved funding for up to five years using the General Service Board Reserve Fund, with the condition that if the magazine was not financially viable after that period, it would be discontinued.

From 1999 to 2018, multiple Conference discussions affirmed La Viña's value as a spiritual tool and its role in Twelfth Step work while emphasizing the goal of becoming self-supporting. Funding La Viña through the General Fund was noted as a concern affecting the overall Fellowship. In 2023, a member submitted a Proposed Agenda Item (PAI) that the Conference review the financial sustainability of continuing to print La Viña. The PAI aimed to create an informed group conscience while affirming La Viña's usefulness.

In 2024, the AA Grapevine Board of Directors was asked to develop a fiveyear financial plan to reduce deficits and increase revenue for La Viña. This plan, which can be found in the <u>background</u> material, will be reviewed at the 2025 Conference.

Progress to date includes the following actions: identified likely 4th Edition "keepers"; read and rated the previously selected 5th edition story submission "keepers"; consulted with current and past Class A trustees on Appendices III and V; reached out to Publishing regarding the new Foreword and updated Preface. The committee reviewed the progress report and summary on the development of a Fifth Edition of *Alcoholics Anonymous*. The committee agreed to forward revised progress reports providing updates from the most recent materials to the oldest materials to the 2025 Conference Committee on Literature.

The subcommittee agreed that additional language would be beneficial to provide a usable reference and decided to add extra content addressing sponsorship for neurodivergent members. According to the Literature Matrix, Living Sober is among the most popular publications, often given to newcomers. A second edition could address changes such as post-pandemic online meeting format, etiquette, and security; recovery resources in various social media platforms; and address specialized groups such as women's, men's, LGBTQIA, BIPOC, secular, neuro-divergent, trauma survivors, etc. while using current language. It may attract new members. The cost of a rewrite may be offset by sales. A revised edition would be consistent with the process of periodically reviewing and revising Conference-approved literature. Historical Context; Why is it on the Agenda?

At the January 2025 General Service Board (GSB) meeting, the trustees' Literature Committee discussed creating a process for reviewing suggested revisions to the Plain Language Big Book (PLBB). In February 2025, the committee revisited the discussion, anticipating a high volume of proposed changes, and agreed to forward a discussion memo to the 2025 Conference Literature Committee. Since the PLBB is a translation, substantive revisions may require input from an outside consultant to ensure accuracy. The memo proposes categorizing revision requests as either editorial or substantive. Editorial changes would not go to the Conference, while substantive changes would first be reviewed by the trustees' Literature Committee (TLC) with a consultant's assistance before being forwarded to the Conference Literature Committee (CLC) for approval. It also suggests postponing any changes to the PLBB for a period of time to allow for more experience with it before considering revisions. Additional considerations include the cost of hiring consultants, the impact on other translation projects, and prioritizing revisions within the Conference Literature Committee's workload. The memo cites a precedent from 2020 when a Committee Consideration requested research on tools for Big Book accessibility before making changes.

In 2023, the Conference Policy & Admissions Committee requested that the trustees' survey current Conference members on the spiritual implications of holding the Conference outside New York or alternating between New York and Akron/Cleveland. In 2024, the Conference Policy & Admissions Committee asked the General Manager for a progress report on site selection for the 77th and 78th General Service Conferences.

Last year, the Conference Policy & Admissions Committee reviewed dates for the 2028 Conference and prioritized flexibility in securing cost-effective and suitable venues. The committee selected, in order of preference: April 23-29, 2028; May 7-13, 2028; and April 2-8, 2028. These dates were chosen to minimize conflicts with major holidays.

The committee requested that trustees and staff finalize an operational procedure and implementation plan, with a progress report presented this year.

Short-term recommendations focus on improving workflow by refining how agenda items are assigned, utilizing trustee reports instead of CAR forms, and ensuring effective tracking and communication of EDW updates. Long-term recommendations include evaluating how EDW items are reassigned, considering the future composition of the EDW committee, and establishing a

Historical Context; Why is it on the Agenda?	A 1986 Advisory Action states that agenda items receiving a simple majority but not the required "substantial unanimity" of a two-thirds vote should be noted in the Conference Report as nonbinding suggestions to the appropriate trustees' Committee or Corporate Board. These items were categorized into three sections: 1) Recommendations passed by simple majority; 2)
	Recommendations not resulting in Conference action; and 3) Floor actions not resulting in Conference advisory actions. While this process is referenced in <i>The A.A. Service Manual</i> and other service literature, there is little information on how the General Service Board has applied it in practice.
	The 2024 Conference Committee on Report and Charter recommended clarifying in the Conference Report that simple majority items did not meet the two-thirds threshold for advisory actions. This year, the Policy & Admissions Conference Committee will review whether the 1986 Advisory Action remains relevant and if forwarding failed recommendations to the trustees aligns with or bypasses the Conference process. Key questions include whether these items should be treated as suggestions or failed recommendations and whether the phrase "strong suggestion" contradicts the Conference's group

Historical Context: Why is it on the Agenda?

This item proposes raising the voting threshold for changes to specific A.A. literature written by the Founders from two-thirds (substantial unanimity) to three-fourths (super majority). This would apply to the first 164 pages of the Big Book, the Preface, Forewords, "The Doctor's Opinion," "Dr. Bob's Nightmare," the Appendices, and the book *Twelve Steps and Twelve* Traditions.

The proposal stems from concerns that recent changes to *Twelve Steps and* Twelve Traditions caused division and that Bill W.'s writings should be preserved as originally published. If approved, this change would make future revisions to these works significantly more difficult.

	Historically, the Conference has had the authority to make literature changes as part of its role in guiding A.A., as outlined in the Conference Charter. Over the years, the General Service Conference has both maintained the Founders' writings and approved updates, including removing outdated language and revising literature to improve accessibility. In late 2024, following a Conference Advisory Action, the PI Desk launched a new campaign with external vendor Connect360 to distribute and track two PSAs (in English, Spanish, and French) on broadcast TV in the U.S. and Canada. In its first quarter, the campaign resulted in over 6,500 airings, valued at more than \$2.6 million in donated airtime—broadcast time that stations voluntarily provide for public service messages at no cost to organizations that serve the public interest.
	The trustees' PI Committee reviewed a detailed distribution report from Connect360. In October, English-language PSAs aired on 42 U.S. stations, with an airtime value of \$999,404, while Spanish-language PSAs aired on 12 U.S. stations, valued at \$73,636. Canadian distribution was temporarily paused until telecaster numbers were assigned and added to digital broadcast files. Tracking reports in the background include demographics, station results, market penetration, and airing details.
	The trustees' PI Committee recommended distributing and evaluating two PSAs at a cost of \$17,000, in addition to the \$48,000 allocated for tracking donated airtime in 2024, keeping total costs within \$65,000. The committee also recommended researching more cost-effective tracking methods for future PSA distribution.

GLOSSARY OF TERMS

Excerpts reprinted from The A.A. Service Manual pp. 89 – 91 with permission of A.A. World Services, Inc.

A.A.W.S. — Alcoholics Anonymous World Services, Inc., one of the two operating corporations of the General Service Board; oversees the operations of the General Service Office and serves as the publishing company for Conference-approved and service literature.

Additional committee consideration — An item discussed by a Conference committee but with no action taken or recommendation made to the full Conference. It serves as a suggestion to the corresponding trustees' committee.

Ad hoc committee — A temporary committee formed to accomplish a specific task. Once its goal is achieved, the committee is disbanded.

Advisory Action — Represents the informed group conscience of the Fellowship, resulting from a Conference committee recommendation or a floor action approved by the full Conference.

Agenda item [Agenda Topic] — A topic suggested by A.A. members, groups, delegates, trustees, area assemblies, committee members, or A.A. staff for discussion at the Conference.

Appointed committee member (ACM) — An A.A. member selected to serve on a specific trustees' committee due to expertise in a relevant field.

Area — One of 93 geographic regions in the U.S. and Canada. Each area elects a delegate to the General Service Conference.

Class A trustee — A nonalcoholic trustee of the General Service Board.

Class B trustee — An alcoholic trustee of the General Service Board.

Conference — The General Service Conference, either as the structure involving A.A. service members or as the annual meeting of delegates in New York (see below).

Conference-approved literature, videos, and films — A.A. materials reviewed and approved by the General Service Conference [for publishing by A.A. World Services].

C.P.C. (Cooperation with the Professional Community) — Committees at various levels that help carry A.A.'s message to professionals who work with alcoholics.

Delegate — The A.A. member elected every two years to represent an area at the General Service Conference and report back on its proceedings.

Director — A member of the corporate board of A.A.W.S. or AA Grapevine, either a trustee or a nontrustee with relevant business experience.

General Service Board (G.S.B.) — The governing board of A.A., consisting of 14 alcoholic trustees (Class B) and seven nonalcoholic trustees (Class A), responsible for overseeing G.S.O., A.A.W.S., and AA Grapevine.

General Service Conference — A gathering linking A.A. groups to G.S.O. and the General Service Board, serving as the collective group conscience for A.A. as a whole.

General Service Office (G.S.O.) — The office that provides services to A.A. groups in the U.S. and Canada and publishes A.A. literature.

Grapevine (GV) — A.A.'s international journal, available in print and online, managed by AA Grapevine, Inc.

La Viña — A.A.'s bimonthly Spanish-language magazine, published by AA Grapevine.

Nontrustee director — An A.A. member serving as a director on A.A.W.S. or AA Grapevine's corporate board but not as a trustee.

Panel — A two-year delegate term; delegates begin their service at the General Service Conference for the panel number assigned to their election year.

P.I. (Public Information) — Committees at different levels responsible for carrying A.A.'s message to the public and media.

Region — A grouping of several areas, each represented by a regional trustee on the General Service Board.

Regional Forum — A weekend sharing session held in each region every two years to improve communication among A.A. members.

Trustee — A member of the General Service Board, either an alcoholic (Class B) or a nonalcoholic (Class A).

Trustee-at-large — A Class B trustee (one from Canada, one from the U.S.) who represents North America at international A.A. service meetings.
