Ask The Delegate:

During my term as Delegate, I will share with you, the Fellowship of Area 74, questions that I get asked each month and my reply. I believe that if one person, group, committee has that question, others will as well.

"Are you aware of the fellowship survey that was released?"

Yes! I hope all of you are too! See below for a snippet. I have ordered 100 of the print pamphlets that I will have available at all in-person events I'm attending.

"We are pleased to share with the Fellowship the results of the 2022 A.A. Membership Survey.

The survey results are now available in a <u>print pamphlet</u> and on a new <u>webpage</u> on aa.org that also offers downloadable infographics. The page can be viewed at <u>aa.org/membership-survey-2022</u>.

More than 6,000 A.A. members took part in a randomized membership survey that was conducted in 2022. The previous survey was conducted in 2014.

For the first time, the survey included topics regarding online A.A. meetings, which became more widely available during the COVID-19 pandemic. Other findings included:

41% of A.A. members have been with the program for more than 20 years
Members attend an average of two A.A. meetings per week
75% of members have attended an A.A. meeting virtually (online or by phone)
79% of members prefer in-person meetings

Another Question;

"Do you happen to know why the U.P. is lumped into Area74? Was it a matter of us being able to meet their needs better than the other two areas at the time (which is now three)? (Referring to Areas 32,33, and 34)"

Sincerely, Alcoholic"

I thought this was a great question and didn't know the answer. I reached out to a few people within Area 74 and as well as the current Delegate from Ed B. Ed lead to their Area Archivist and Delegate from Panel 54 – Mike Y who provided me with this explanation.

"Nicholas the whole of the UP was originally Area 34, which encompasses the west side of Michigan from Indiana to the U.P. Due to the distance for travel to Area meetings, the groups of the U.P. voted to do service in Area 74. Later groups from Newberry east felt with the formation of Northern Michigan Inter Area Intergroup that their service would be less travel in Area 34 and NMIA as well as better assistance with carrying the message into the federal/state prisons located there. Hope that answers the question."

Makeup of the 74th General Service Conference

There are 136 voting members of the 74th General Service Conference Annual Meeting.

Ninety-three delegates elected by the service areas of the U.S. and Canada comprise 68.38 percent of the voting body. Delegates always make up more than two-thirds of the voting members.

The General Service Office staff, general manager and Grapevine office staff and the Grapevine executive editor/publisher, totaling 15, comprise 11.04 percent of the total.

General Service Board of Trustees and Alcoholics Anonymous World Services, Inc. (A.A.W.S.) and Grapevine directors, totaling 28, comprise 20.58 percent of the voting members.

The usual composition of the General Service Board of Alcoholics Anonymous consists of twenty-one trustee members.

Seven trustees, known as Class A trustees, are nonalcoholic. Class A trustees bring to the Board special expertise in areas such as business, medicine, and law, and are asked to serve for six years.

The alcoholic (Class B) trustees serve for four years. Eight regional trustees are elected, one from each of the regions of the U.S. and Canada. Two trustees-at-large are elected, one from the U.S. and one for Canada. The remaining trustees, called general service trustees, are selected based on their expertise in areas of finance, publishing, or other fields that would be helpful to the General Service Board and its corporate boards. Currently, there are three general service trustees.

The A.A.W.S. Board oversees the activities of Alcoholics Anonymous World Service, Inc. (except for Grapevine material) and the General Service Office. This board is currently composed of nine directors: two regional trustees, two general service trustees, three non-trustee directors, the general manager of G.S.O. and the G.S.O. staff coordinator.

The Grapevine Board oversees the operation of A.A. Grapevine, Inc., and is composed of nine members, including one Class A trustee, two general service trustees, two regional trustees, three non-trustee directors and the Grapevine executive editor/publisher.

I want to provide an update to my most recent letter regarding AA's finances in which I shared details of the challenges we've been facing and the need for sustained increases in contributions. The response from the Fellowship in the last two months has been extremely heartwarming. We have heard from many of you expressing your support, concerns, and understanding in the form of heartfelt messages and generous contributions to the General Service Board. I want to personally express my deep gratitude and sincere thanks to each and every one of you.

I'm very encouraged and happy to share that we have seen recent increases in both the number of contributions received as well as total dollar amounts. In fact, in December, we received contributions from more than 9,000 groups and members. The average we typically receive in December is 6,900. This increased participation has resulted in the highest amount ever received in the month of December, just over \$1.65 million. We also saw an increase in participation in November just following the call for help. On a year-to-date basis, contributions to the General Service Board also have exceeded the highest ever received at over \$10.8 million. This amount also exceeds the amount budgeted for 2023, which was \$10.5 million.

Your positive response and increases in participation and dollar amounts have been very helpful to operations in the last few months, however, we are still facing difficulties meeting expenses. Gross literature sales in December were strong, but profits for 2023 will be below budget. As I mentioned in my November message, the reduction in literature sales and profits has been the driving factor in the loss in income. Although contributions have increased post-pandemic, literature profits have dropped at a higher rate. Our literature is a vital spiritual tool and service to our Fellowship. The volume in which it is purchased is based on the needs of the Fellowship. It is very important to keep it affordable so it can be distributed as widely as possible and ensuring it finds its way into the hands of those who need it. But we cannot rely on increased literature profits to solve our financial challenges.

In addition, the ability to rebuild the Reserve Fund is also challenging. As of December year end, the balance is sufficient to cover approximately 7.28 months' operating expenses, which is less than the general expectation of 9 to 12 months.

Your overwhelming response also brings to mind the principle of participation that resides within our Seventh Tradition. Even more significant than financial contributions is our participation, which fills us with the spirit of belonging and connection to AA This is in line with the overarching goal to meet and overcome our financial challenges in the long term. That is, more frequent and sustained contributions but also from a larger representation of our groups and members.

Bill W.'s insights on the Seventh Tradition reinforce the answer to our financial challenges:

"But this leaves us with a responsibility — one that every member ought to understand. We cannot skimp when the treasurer of our group passes the hat. Our groups, our areas, and AA as a whole will not function unless our services are sufficient and their bills are paid. "When we meet and defeat the temptation to take large gifts, we are only being careful. But when we are generous with the hat we give a token that we are grateful for our blessings and evidence that we are eager to share what we have found with all those who still suffer." (The Language of the Heart, p. 221)

The AAWS and AA Grapevine Boards, in strong collaboration with the office, have been working very hard for the last several months preparing the 2024 budget. The General Service Board will review, discuss, and finalize the budget during their next scheduled quarterly Board Weekend at the end of this month. Several projects and items have been deferred in order to present a balanced budget.

So let's keep it going—continued participation! Perhaps your group, or you personally, may consider setting up a reoccurring contribution to the General Service Board. It's very simple to set up through our online contributions site, which can be accessed through AA.org or by clicking here. There are options to make a one-time, weekly, monthly, quarterly, or yearly contribution.

Thank you again for your participation not only with our Seventh Tradition but with all each and every one of you do for our beloved Fellowship. Your participation is the very best investment in AA's future and keeps Alcoholics Anonymous vibrant and available for all who need it today, tomorrow, and beyond.
